17	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

19	SECTION 1. Arkansas Code Title 27, Chapter 24, Subchapter 14, is			
20	amended to add an additional section to read as follows:			
21	27-24-1411. Arkansas Nurses Association.			
22	(a) The Director of the Department of Finance and Administration shall			
23	issue a special license plate for the Arkansas Nurses Association in the			
24	manner and subject to the conditions provided for under this subchapter.			
25	(b) The specia	al motor vehicle license plate un	nder this section shall	
26	<u>be:</u>			
27	<u>(1)(A) I</u>	Designed by the Arkansas Nurses A	Association;	
28	<u>(B)</u>	The design shall be submitted	for design approval by	
29	the director under rules promulgated by the director; and			
30	(2) Numbered consecutively.			
31	(c) The director shall determine the amount of the costs for the			
32	issuance of the special license plate under this section as follows:			
33	(1) The fee for the cost of initial orders of the new design,			
34	which shall be based on the cost of the initial order;			
35	<u>(2) The</u>	number of applications that must	t be received to cover	
36	the cost of the init	ial order of the new design: or		

1	(3) The combination of subdivisions (c)(1) and (2) of this		
2	section that must be received to cover the cost of the initial order of the		
3	new design.		
4	(d) The department shall issue a special license plate under this		
5	section upon payment of:		
6	(1) The fee required by law for registration of the motor		
7	vehicle;		
8	(2)(A) Twenty-five dollars (\$25.00) to cover the design-use		
9	contribution.		
10	(B) The design-use contribution shall be remitted monthly		
11	to the Arkansas Nurses Association to be used for association purposes; and		
12	(3)(A) A handling and administrative fee of ten dollars		
13	<u>(\$10.00).</u>		
14	(B) The handling and administrative fee shall be:		
15	(i) Deposited into the State Central Services Fund		
16	for the benefit of the Revenue Division of the Department of Finance and		
17	Administration; and		
18	(ii) Credited to the division as supplemental and in		
19	addition to all other funds that may be deposited for the benefit of the		
20	division.		
21	(C) The handling and administrative fee shall not be		
22	considered or credited to the division as direct revenue.		
23	(e)(1) A special license plate issued under this section may be		
24	renewed annually or replaced under the procedures set out in § 27-24-1405.		
25	(2) However, the division shall remit the fees collected under §		
26	27-24-1405(b)(2) on a monthly basis to the association.
