8	(1) Recorded by the county recorder in the land records of the

10	(2) Indexed by the county recorder in the general index under		
11	the names of the original parties to the instrument as they are identified in		
12	the scrivener's affidavit;		
13	(3) Admissible as evidence in an action involving the instrument		
14	to which it relates or the title to the real property affected by the		
15	instrument; and		
16	(4) Prima facie evidence of the facts stated in the scrivener's		
17	affidavit and the marketability of the title to real property.		
18	(d)(1) Except as provided in subdivision (d)(2) of this section,		
19	notice of the corrective information provided by the scrivener's affidavit is		
20	effective at the time the scrivener's affidavit is recorded.		
21	(2) If an error contained in a scrivener's affidavit is of an		
22	obvious nature, notice of the corrective information provided by the		
23	scrivener's affidavit is effective at the time the original instrument being		
24	corrected was recorded.
