13	Subtitle
14	TO EVALUATE THE IMPACT OF SCHOOL
15	DISCIPLINE ON STUDENT ACHIEVEMENT.
16	
17	
18	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
19	
20	SECTION 1. <u>LEGISLATIVE FINDINGS</u> . The General Assembly finds that:
21	(1) There are many factors that contribute to poor student
22	performance including lost instruction time or chronic absence;
23	(2) A student who has been suspended even once is less likely to
24	graduate;
25	(3) Discipline that keeps students engaged in the learning
26	process and in the school community is more effective than discipline that
27	interrupts the learning process and separates the student from the school
28	<pre>community;</pre>
29	(4) Out-of-school suspensions are necessary in some situations
30	but the excessive use of out-of-school suspension as a discipline measure is
31	harmful to the educational process; and
32	(5) Disparity in discipline rates does not necessarily indicate
33	discrimination; it can result from an ineffective school climate or from
34	cultural strategies that are not successful in engaging the academic efforts
35	of all students.

1	SECTION 2. Arkansas Code § 6-18-507(b), concerning school district
2	authority to suspend or expel students, is amended to read as follows:
3	(b) The board of directors of a school district may suspend or expel
4	any student from school for violation of the school district's written
5	discipline policies, except that a school district shall not use out-of-
6	school suspension as a discipline measure for truancy.
7	
8	SECTION 3. Arkansas Code § 6-18-507, concerning school district
9	authority to suspend or expel students, is amended to add an additional
10	subsection to read as follows:
11	(g) A public school shall indicate on a student's attendance record if
12	a student's absence is the result of an out-of school suspension.
13	
14	SECTION 4. Arkansas Code Title 6, Chapter 18, Subchapter 5, is amended
15	to add an additional section to read as follows:
16	6-18-515. Effective school discipline.
17	(a) As used in this section:
18	(1) "Disciplinary rate" means a three-year average for each
19	discipline measure of the number of students in a school district or the
20	number of students in a subgroup in the school district who have at least one
21	(1) discipline measure divided by the corresponding total enrollment in the
22	school district or the total enrollment in the subgroup;
23	(2) "Discipline measure" means:
24	(A) In-school suspension;
25	(B) Out-of-school suspension;
26	(C) Expulsion;
27	(D) Corporal punishment; and
28	(E) Referrals to law enforcement authorities;
29	(3) "Rate of disciplinary disparity" means the disciplinary rate
30	for a subgroup subtracted from the disciplinary rate for another comparison
31	subgroup; and
32	(4) "Subgroup" means the enrollment of students in one (1) of
33	the following demographic groups:
34	(A) White students;
35	(B) Nonwhite students;
36	(C) Low-income students, including without limitation

1	students who are economically disadvantaged for standardized testing
2	purposes;
3	(D) Students with disabilities, defined as "a child with a
4	disability" under § 6-41-203; and
5	(E) Students whose achievement is at the basic or below
6	basic level, or the equivalent, for the school year on the state-required:
7	(i) Literacy benchmark assessments;
8	(ii) Mathematics benchmark assessments; or
9	(iii) End-of-course assessments.
10	(b) By July 1 of each year beginning in 2014, the Department of
11	Education shall prepare and provide a report to the State Board of Education
12	and to all school districts that includes the following information:
13	(1) The total number of students enrolled in the school district
14	and in each subgroup;
15	(2) The percentage that each subgroup represents of the school
16	district's total enrollment;
17	(3) The number of students who appear in more than one (1)
18	subgroup;
19	(4) The disciplinary rate for each discipline measure for the
20	total student enrollment in a school district;
21	(5) The disciplinary rate for each discipline measure for each
22	subgroup; and
23	(6) The rate of disciplinary disparity for each discipline
24	measure for each subgroup compared with the subgroup with the lowest
25	disciplinary rate.
26	(c) The report also:
27	(1) May include additional information that the department
28	determines will provide a better understanding of the disciplinary rate or
29	rate of disciplinary disparity of a particular school or school district;
30	(2) Shall include the achievement status for a school district
31	identified in the report; and
32	(3) Shall identify discipline-related strategies, alternatives,
33	and resources available to school districts.
34	(d) The department shall:
35	(1) Track the progress that school districts in the state have
36	made in reducing the disciplinary rate and rate of disciplinary disparity

1	and:
2	(2) Identify school districts that make progress reducing the
3	disciplinary rate and rate of disciplinary disparity and assess the
4	successful strategies used by those school districts;
5	(3) Assess the gains, if any, in student academic achievement
6	that correspond to the reduction of disciplinary rates and rates of
7	disciplinary disparity; and
8	(4) Report annually to the state board the information under
9	subdivisions (d)(1)-(3) of this section:
10	(A) The progress made for the year;
11	(B) Successful strategies that may be used by other school
12	districts; and
13	(C) The corresponding gains, if any, in student academic
14	achievement.
15	(e)(1) The department shall survey districts to determine which school
16	districts are currently implementing evidence-based strategies, including
17	without limitation:
18	(A) Positive behavior interventions and support systems;
19	<u>and</u>
20	(B) Restorative justice.
21	(2) The department shall:
22	(A) Develop information concerning the resources needed by
23	school districts to reduce discipline and the restraint of students with
24	disabilities using the strategies in subdivision (e)(1) of this section; and
25	(B) Provide the information for inclusion in the
26	educational adequacy study required under § 10-3-2102(a)(1)-(4).
