33	SECTION 1. The purpose of this bill is to take appropriate legislative		
34	action to declare a steel mill project to be a qualified Amendment 82 project		
35	under the Arkansas Amendment 82 Implementation Act, § 15-4-3201 et seq.; to		
36	establish additional parameters deemed necessary by the General Assembly for
