25	amended to read as follows to correct an internal reference:
26	(d) This subdivision (a)(2) <del>(B)(i)<u>(</u>A)(i)</del> <del>shall apply</del> <u>applies</u> to all
27	members and retirants.

29	SECTION 2. Arkansas Code § 24-10-102(28), concerning the definition of
30	"political subdivision" under the Arkansas Local Police and Fire Retirement
31	System, is amended to read as follows to use the preferred singular noun

12	Revenue Fund Account of the State Apportionment Fund.

14	SECTION 4. Arkansas Code § 24-11-801(a)(4)(B), concerning the
15	definition of "member" in relation to the qualifications required for
16	membership on a board of trustees of a firemen's pension and relief fund, is
17	amended to read as follows to clarify the wording:
18	(B) <del>(i)</del> As used in this section, "member" includes an
19	active or retired member of the fund.
20	<del>(ii) "Member"</del> <u>but</u> does not include a beneficiary of
21	the fund.

23	SECTION 5. DO NOT CODIFY. The enactment and adoption of this act
24	shall not repeal, expressly or impliedly, the acts passed at the regular
25	session of the Eighty-Ninth General Assembly. All such acts shall have the
26	full force and effect and, so far as those acts intentionally vary from or
27	conflict with any provision contained in this act, those acts shall have the
28	effect of subsequent acts and as amending or repealing the appropriate parts
29	<u>of the Arkansas Code of 1987.</u>
