 34 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TURNBACK  
 35 FUNDS. Any Federal Mineral Leasing Funds, Federal Forest Reserve Funds,  
 36 Federal Flood Control Funds, or any similar turnback funds in the State

1 Treasury for which the eligible county and/or school district cannot be  
2 identified may be transferred to the Department of Education Public School  
3 Fund Account and used for any lawful school purpose.

4 The provisions of this section shall be in effect only from July 1, ~~2012~~  
5 2013 through June 30, ~~2013~~ 2014.

7 SECTION 22. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
8 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CARRY  
9 FORWARD. Notwithstanding any law pertaining to the transfer of year-end fund  
10 balances or any law to the contrary, any funds which remain in the Department  
11 of Education Fund Account at the end of a fiscal year shall remain in the  
12 Department of Education Fund Account and made available to fund appropriation  
13 authorized by law and made payable from the Department of Education Fund  
14 Account for the following fiscal year.

15 Any carry forward of unexpended balance of funding as authorized  
16 herein, may be carried forward under the following conditions:

17 (1) Prior to June 30, ~~2013~~ 2014 the Agency shall by written statement

20 (2) The Department of Finance and Administration Office of Budget shall  
21 report to the Arkansas Legislative Council all amounts carried forward by the  
22 September Arkansas Legislative Council or Joint Budget Committee meeting  
23 which report shall include the name of the Agency, Board, Commission or  
24 Institution and the amount of the funding carried forward, the program name  
25 or line item, the funding source of that appropriation and a copy of the  
26 written request set forth in (1) above;

27 (3) Each Agency, Board, Commission or Institution shall provide a  
28 written report to the Arkansas Legislative Council or Joint Budget Committee  
29 containing all information set forth in item (2) above, along with a written  
30 statement as to the current status of the project, contract, purpose etc. for  
31 which the carry forward was originally requested no later than thirty (30)  
32 days prior to the time the Agency, Board, Commission or Institution presents  
33 its budget request to the Arkansas Legislative Council/Joint Budget  
34 Committee; and

35 (4) Thereupon, the Department of Finance and Administration shall  
36 include all information obtained in item (3) above in the budget manuals

1 and/or a statement of non-compliance by the Agency, Board, Commission or  
2 Institution.

3  
4 SECTION 23. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
5 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. SALARY OF  
6 THE COMMISSIONER OF THE DEPARTMENT OF EDUCATION. It is the intent of the  
7 General Assembly that the appropriation for the salary of the Commissioner of  
8 the Department of Education shall be the sole and exclusive authority for his  
9 or her salary. It is further the intent of the General Assembly that the  
10 Commissioner be required to devote all of his or her working time exclusively  
11 to the performance of his or her duties as Commissioner of the Department of  
12 Education. Therefore, the Commissioner of the Department of Education is  
13 hereby prohibited from accepting any additional salary from any other source  
14 (including state, federal, or private entities or persons) for the  
15 performance of his or her duties as Commissioner, and is prohibited from  
16 accepting any salary, fees or compensation from any other source (including  
17 state, federal or private entities or persons) for any other employment of  
18 any kind outside the scope of his or her duties as Commissioner, including  
19 but not limited to consulting work for any other public or private entity.  
20 This section shall not be construed to prohibit the Commissioner from  
21 accepting or receiving expense reimbursements and employee benefits as  
22 provided by State law.

23  
24 SECTION 24. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
25 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.  
26 ESTABLISHMENT OF A "POSITION POOL".

27 (a) To address needs emerging from statewide education issues and the  
28 necessity of recruiting and retaining qualified personnel, the Arkansas  
29 Department of Education or its successor agency is authorized for the ~~2012-~~  
30 ~~2013~~ 2013-2014 fiscal year a pool of no more than five (5) ~~non-classified~~  
31 ~~positions at a maximum salary level not to exceed one hundred twenty five~~  
32 ~~thousand dollars (\$125,000) per year.~~ Professional/Executive positions at a  
33 salary not to exceed the maximum salary for a grade N912. These positions are  
34 to be used by the Department of Education in the event that the personal  
35 services needs of the Department during the ~~2012-2013~~ 2013-2014 fiscal year  
36 require additional positions, either by title or in number, that are not

1 authorized by the General Assembly in Section 1 of this Act. These positions  
2 may also be used to properly classify positions when the Department does not  
3 have a vacant position available with the appropriate title and salary level.

4 (b) To address needs emerging from statewide education issues and the  
5 necessity of recruiting and retaining qualified personnel, the Arkansas  
6 Department of Education or its successor agency is authorized for the ~~2012-~~  
7 ~~2013~~ 2013-2014 fiscal year a pool of twenty-five (25) classified positions at  
8 up to a grade C130. These positions are to be used by the Department of  
9 Education in the event that the personal services needs of the Department  
10 during the ~~2012-2013~~ 2013-2014 fiscal year require additional positions,  
11 either by classification or in number, that are not authorized by the General  
12 Assembly in Section 1 of this Act. These positions may also be used to  
13 properly classify positions when the Department does not have a vacant  
14 position available with the appropriate title and grade level.

15 (c) Any salary determinations or adjustments administered under the  
16 provisions of Subsections (a) and (b) of this Section shall be made by  
17 comparing the qualifications and salary levels of similar employees in school  
18 districts or in other state education agencies.

19 (d) The Department of Education is authorized to access the pool  
20 positions authorized in this Section at any time when it is determined by the  
21 Commissioner that the need exists. The Commissioner shall provide a  
22 quarterly report of the justification for the need to allocate titles from  
23 this growth pool to the Chief Fiscal Officer of the State and to the Arkansas  
24 Legislative Council for review. The report shall also include an accounting  
25 of the names, titles, and salaries of personnel whose salaries have been  
26 adjusted under provisions of Subsections (a) and (b) of this Section.

27 (e) If the Department of Education requests continuation of any  
28 "Position Pool" position(s) as established herein during the next fiscal  
29 year, the position(s) must be requested as a new position(s) in the agency's  
30 budget request.

31 (f) Determining the number of personnel to be employed by a state agency  
32 is the prerogative of the General Assembly and is usually accomplished by  
33 delineating the maximum number of personnel by identifying job titles and the  
34 maximum grade or salary attached to those titles. The General Assembly has  
35 determined that the Arkansas Department of Education could be operated more  
36 efficiently if some flexibility is given to that agency. That flexibility is

1 being accomplished by providing a position pool in Subsections (a) and (b) of  
2 this Section and since the General Assembly has granted the agency broad  
3 powers under the growth pool concept, it is both necessary and appropriate  
4 that the General Assembly maintain oversight of the utilization of the  
5 position pool by requiring review of the Legislative Council in the  
6 utilization of the position pool. Therefore, the requirement of review by the  
7 Legislative Council is not a severable part of this section. If the  
8 requirement of review by the Legislative Council is ruled unconstitutional by  
9 a court of competent jurisdiction, this entire section is void.

10 The provisions of this section shall be in effect only from July 1, ~~2012~~  
11 2013 through June 30, ~~2013~~ 2014.

12  
13 SECTION 25. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
14 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. ARKANSAS  
15 LEADERSHIP ACADEMY - REDUCTION OF FUNDS RESTRICTION. Upon determination by  
16 the Department of Education that a reduction in the amount of available  
17 appropriation within the Department of Education Fund Account is required  
18 from the amount appropriated, the reduction in the available appropriation  
19 from the full amount appropriated for the Arkansas Leadership Academy shall  
20 be limited to the average percentage reduction in the other appropriations to  
21 the Department of Education from the Department of Education Fund Account.

22 The provisions of this section shall be in effect only from July 1, ~~2012~~  
23 2013 through June 30, ~~2013~~ 2014.

24  
25 SECTION 26. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
26 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.  
27 LEADERSHIP ACADEMY. The funds appropriated in the "AR LEADERSHIP ACADEMY"  
28 line item in Section 3 of this Act shall be used for the School Support  
29 Program which will provide support to schools or school districts designated  
30 by the Department of Education as being in school improvement status and to  
31 provide for general operations of the Leadership Academy.

32 The provisions of this section shall be in effect only from July 1, ~~2012~~  
33 2013 through June 30, ~~2013~~ 2014.

34  
35 SECTION 27. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
36 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. PULASKI

1 COUNTY DESEGREGATION CASE COSTS FUND TRANSFER. The Department of Education  
2 shall retain and use any unexpended balance of funds transferred to the  
3 Department of Education Fund Account during the 2007-09 biennium for the  
4 purpose of providing funds for Pulaski County Desegregation Case Costs  
5 incurred by the Department of Education and the three (3) Pulaski County  
6 School Districts to comply with the provisions of Arkansas Code §6-20-415 and  
7 §6-20-416. These retained funds shall be used exclusively to provide funds  
8 for Pulaski County Desegregation Case Costs incurred by the Department of  
9 Education and the three (3) Pulaski County School Districts under Arkansas  
10 Code §6-20-415 and §6-20-416.

11 No portion of these retained funds shall be expended by the Department of  
12 Education without certification by the Commissioner of the Department of  
13 Education to the Chief Fiscal Officer of the State and prior approval by the  
14 Chief Fiscal Officer of the State.

15 The provisions of this section shall be in effect only from July 1, ~~2012~~  
16 2013 through June 30, ~~2013~~ 2014.

17  
18 SECTION 28. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
19 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. STATE  
20 FUND RESTRICTIONS. No state funds shall be used for abortion referral in  
21 public schools, or for abortion services. Funds shall be expended in  
22 accordance with Arkansas Code Annotated § 6-18-703.

23 The provisions of this section shall be in effect only from July 1, ~~2012~~  
24 2013 through June 30, ~~2013~~ 2014.

25  
26 SECTION 29. COMPLIANCE WITH OTHER LAWS. Disbursement of funds  
27 authorized by this act shall be limited to the appropriation for such agency  
28 and funds made available by law for the support of such appropriations; and  
29 the restrictions of the State Procurement Law, the General Accounting and  
30 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
31 Procedures and Restrictions Act, or their successors, and other fiscal  
32 control laws of this State, where applicable, and regulations promulgated by  
33 the Department of Finance and Administration, as authorized by law, shall be  
34 strictly complied with in disbursement of said funds.

35  
36 SECTION 30. LEGISLATIVE INTENT. It is the intent of the General



1 Assembly that any funds disbursed under the authority of the appropriations  
2 contained in this act shall be in compliance with the stated reasons for  
3 which this act was adopted, as evidenced by the Agency Requests, Executive  
4 Recommendations and Legislative Recommendations contained in the budget  
5 manuals prepared by the Department of Finance and Administration, letters, or  
6 summarized oral testimony in the official minutes of the Arkansas Legislative  
7 Council or Joint Budget Committee which relate to its passage and adoption.  
8

9 SECTION 31. EMERGENCY CLAUSE. It is found and determined by the  
10 General Assembly, that the Constitution of the State of Arkansas prohibits  
11 the appropriation of funds for more than a one (1) year period; that the  
12 effectiveness of this Act on July 1, 2013 is essential to the operation of  
13 the agency for which the appropriations in this Act are provided, and that in  
14 the event of an extension of the legislative session, the delay in the  
15 effective date of this Act beyond July 1, 2013 could work irreparable harm  
16 upon the proper administration and provision of essential governmental  
17 programs. Therefore, an emergency is hereby declared to exist and this Act  
18 being necessary for the immediate preservation of the public peace, health  
19 and safety shall be in full force and effect from and after July 1, 2013.
