1	(a) By September 1 each year, each organization shall provide a list		
2	of foreign exchange students placed in Arkansas for the current school year,		
3	including the:		
4	(1) Name of the student;		
5	(2) Home country of the student;		
6	(3) Name, address, and telephone number of the student's parent		
7	or legal guardian;		
8	(4) Name, address, and telephone number of the student's host		
9	family; and		
10	(5) Public or Private school the student attends.		
11	(b) The Secretary of State shall maintain a list of foreign exchange		
12	students placed in Arkansas for the current school year using the information		
13	provided under subsection (a) of this section.

15	6-18-1710. Safety - Fines.		
16	(a) An organization shall adopt policies to ensure that no foreign		
17	exchange student is subjected to child maltreatment.		
18	(b)(1) If the Department of Human Services investigates and makes a		
19	true finding of child maltreatment against a foreign exchange student, the		
20	department shall notify the Secretary of State and the organization shall be:		
21	(A) Fined five thousand dollars (\$5,000) for the first		
22	occurrence;		
23	(B) Fined ten thousand dollars (\$10,000) for the second		
24	occurrence; and		
25	(C) Banned from registering in the state for the third		
26	occurrence.		
27	(2) Fines collected by the Secretary of State under this section		
28	shall be deposited into the State Treasury and credited to the General		
29	Revenue Fund.		
30	(c) The Secretary of State, upon notification of a true finding of		
31	child maltreatment against a foreign exchange student, shall report the		
32	occurrence and the organization to the Council on Standards for International		
33	Educational Travel and the United States Department of State.
