| 22 | An organization that fails to register as required by this subchapter |
| 23 | or that submits false or incorrect information to the Secretary of State in |
| 24 | filing statements required by this subchapter, whether or not the statement |
| 25 | or report is verified, shall be prohibited from placing not place foreign |
| 26 | exchange students with a host family or in a public or private school in this |
| 27 | state during the following academic year tif the organization: |
| 28 | (1) Fails to register as required under this subchapter; |
| 29 | (2) Submits false or incorrect information to the Secretary of |
