27	SECTION 1. Arkansas Code § 26-51-306(a)(1), concerning the income tax
28	treatment of compensation and benefits from military service, is amended to
29	add an additional subdivision to read as follows:
30	(D)(i) For tax years beginning on or after January 1,
31	2015, the service pay or allowance received by an active duty member of the
32	armed services is exempt from the income tax imposed under this chapter.
33	(ii) "Active duty member of the armed services"
34	means all members of the armed forces, including the National Guard and
35	Reserve units.
