10	of execution is ordered, at the time named in the sentence, to cause the

17	or an assistant, the Department of Correction official in charge of medical		
18	services or his or her designee, and a number of respectable citizens		
19	numbering not fewer than six (6) nor more than twelve (12) whose presence is		
20	necessary to verify that the execution was conducted in the manner required		
21	by law. Counsel for the person being executed and the spiritual adviser to		
22	the person being executed may be present. Other persons designated by the		
23	director may be present, but the maximum number of persons at the execution		
24	shall not exceed thirty (30).		
25	(A) The director or an assistant designated by the		
26	director;		
27	(B) The Department of Correction official in charge of		
28	medical services or his or her designee;

28	(i) The spouse of the victim at the time of the		
29	victim's death;		
30	(ii) The parents or stepparents of the victim;		
31	(iii) The adult brothers, sisters, children, or		
32	stepchildren of the victim; or		
33	(iv) Any other adult relative with a close		
34	relationship to the victim.		
35	(C) "Surviving innocent victims" means any person		
36	innocently present during the commission of the capital offence who sustains		

T	an injury, either physical or emotional, and such injury results in a
2	separate conviction for a lesser offense which arises out of the same course
3	of conduct.
