2	SECTION 3. EMERGENCY CLAUSE. It is hereby found and determined by the		
3	General Assembly that the effectiveness of this Act on July 1, 2013 is		
4	essential to the operation of programs supported by funds deposited into and		
5	contained in the Securities Department Fund, and that in the event of the		
6	extension of the legislative session, the delay in the effective date of this		
7	Act beyond July 1, 2013 could work irreparable harm upon the proper		
8	administration and provision of essential governmental programs. Therefore,		
9	an emergency is declared to exist and this Act being immediately necessary		
10	for the preservation of the public peace, health and safety shall be in full		
11	force and effect from and after July 1, 2013.
