12	to the association to be used for association purposes; and		
13	(3)(A) A handling and administrative fee of ten dollars		
14	<u>(\$10.00).</u>		
15	(B) The handling and administrative fee shall be:		
16	(i) Deposited into the State Central Services Fund		
17	for the benefit of the Revenue Division of the Department of Finance and
