1	(b)(1) The appointed board members shall be residents of the State of		
2	Arkansas at the time of appointment and throughout their terms.		
3	(2)(A) During the term of appointment to the board, a member		
4	shall not hold office in, serve in an executive or representative capacity		
5	for, or hold a position in any nongovernmental towing industry organization.		
6	(B) This subdivision (b)(2) does not limit a member of the		
7	board from being a member in a nongovernmental towing industry organization.

9	SECTION 2. Arkansas Code § 27-50-1203(e)(1), concerning the Arkansas		
10	Towing and Recovery Board, is amended to add two additional subdivisions to		
11	read as follows:		
12	(H) Requiring all entities permitted, licensed, or		
13	regulated under this subchapter to maintain personnel at storage facilities		
14	for eight (8) hours between the hours of 8:00 a.m. to 5:00 p.m. on any day		
15	for which storage fees are charged; and		
16	(I) Requiring all entities permitted, licensed, or		
17	regulated under this subchapter to charge storage fees only for each twenty-		
18	four-hour period following the time the entity takes possession of a vehicle,		
19	implement, or piece of machinery.
