26	WHEREAS, Mr. Holsted was a 1962 graduate of North Little Rock High
27	School in North Little Rock, Arkansas, and attended Vanderbilt University
28	where he played basketball and graduated in 1967; and

30	WHEREAS, Mr. Holsted worked as a financial advisor at Wells Fargo
31	Advisors; and

33	WHEREAS, Mr. Holsted served in the Arkansas General Assembly as a State
34	Senator; was a past president and long-time treasurer of the Rotary Club of
35	Mountain Home; served Baxter Regional Medical Center on their investment
36	committee; and was a member of the development council of Arkansas State

3	WHEREAS, Mr. Holsted sponsored the Mountain Home High School Athlete of
4	the Week; mentored at-risk youth at Baxter County Alternative School; served
5	in various capacities with the Christian Business Men's Committee; led the
6	Twin Lakes Bike Club; and was a member of the Central Arkansas Recreational
7	Pedalers, in which he was instrumental in establishing bike trails at
8	Syllamo, Camp Robinson, and Pigeon Creek, Arkansas; and

10	WHEREAS, Mr. Holsted's dedication to the Lord led him to become a
11	Charter Member of Lakewood United Methodist Church of North Little Rock,
12	Arkansas, worship leader at First United Methodist Church, and a lay director
13	and Chairman of the Board of Walk of Emmaus, also at First United Methodist
14	Church; and

16	WHEREAS, over the years, Mr. Holsted accomplished much as a family man,
17	a business man, and pillar of his community, touching many lives with his
18	vibrant personality, his positive attitude toward the future, and his zeal
19	for life; and

21	WHEREAS, Mr. Holsted is survived by his wife of forty-eight (48) years,
22	Joyce Elaine Holsted; his daughter Susan Stockton and her husband, Mike of
23	Mountain Home, Arkansas; his son, Chris Holsted and his wife, Sara of Murphy,
24	Texas; his six (6) grandchildren, Dalton Rebsamen, Rachel Alexander, Kylie
25	Holsted, Connor Holsted, MacKenzie Holsted, and Lawson Stockton; his three
26	(3) brothers, Jay Holsted and wife Martha of Denver, Colorado; David Holsted
27	and his wife, Nancy of North Little Rock, Arkansas; and Bruce Holsted and
28	wife Becky of North Little Rock, Arkansas; and a host of nephews, nieces,
29	other relatives, and friends; and

31	WHEREAS, the Senate wishes to publically recognize Mr. Holsted's
32	contributions to the State of Arkansas and his local community,
