20	summarized oral testimony in the official minutes of the Ark	ansas Legislative	
21	Council or Joint Budget Committee which relate to its passag	ge and adoption.

23	SECTION 4. EMERGENCY CLAUSE. It is found and determin	ed by the General	
24	Assembly, that the Constitution of the State of Arkansas pro	hibits the	
25	appropriation of funds for more than a one (1) year period;	that the	
26	effectiveness of this Act on July 1, 2014 is essential to the	e operation of	
27	the agency for which the appropriations in this Act are prov	rided, and that in	
28	the event of an extension of the legislative session, the de	elay in the	
29	effective date of this Act beyond July 1, 2014 could work in	reparable harm	
30	upon the proper administration and provision of essential go	<u>vernmental</u>	
31	programs. Therefore, an emergency is hereby declared to exis	t and this Act	
32	being necessary for the immediate preservation of the public	peace, health	
33	and safety shall be in full force and effect from and after	July 1, 2014.
