20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. REGULAR SALARIES - OPERATIONS. There is hereby established
23 for the Arkansas Governor's Mansion Commission for the 2014-2015 fiscal year,
24 the following maximum number of regular employees.

 2 SECTION 2. EXTRA HELP - OPERATIONS. There is hereby authorized, for
 3 the Arkansas Governor's Mansion Commission for the 2014-2015 fiscal year, the
 4 following maximum number of part-time or temporary employees, to be known as
 5 "Extra Help", payable from funds appropriated herein for such purposes: four
 6 (4) temporary or part-time employees, when needed, at rates of pay not to
 7 exceed those provided in the Uniform Classification and Compensation Act, or
 8 its successor, or this act for the appropriate classification.

9
 10 SECTION 3. APPROPRIATION - OPERATIONS. There is hereby appropriated,
 11 to the Arkansas Governor's Mansion Commission, to be payable from the State
 12 Central Services Fund, for personal services and operating expenses of the
 13 Arkansas Governor's Mansion Commission for the fiscal year ending June 30,
 14 2015, the following:

 26 SECTION 4. APPROPRIATION - GRAND HALL/MANSION/GROUNDS. There is hereby
 27 appropriated, to the Arkansas Governor's Mansion Commission, to be payable
 28 from the cash fund deposited in the State Treasury as determined by the Chief
 29 Fiscal Officer of the State, for expenses of the Arkansas Governor's Mansion,
 30 Grand Hall and grounds of the Arkansas Governor's Mansion Commission for the
 31 fiscal year ending June 30, 2015, the following:

1 SECTION 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
2 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER
3 PROVISION. After receiving approval from the Chief Fiscal Officer of the
4 State, and prior review by the Arkansas Legislative Council, the Agency is
5 authorized to transfer appropriation from line items (01) and (03) authorized
6 in Section 3 Appropriation - Operations of this Act to the Mansion Expense
7 line item authorized in Section 3.

8 The provisions of this section shall be in effect only from July 1, ~~2013~~
9 2014 through June 30, ~~2014~~ 2015.

10
11 SECTION 6. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
12 authorized by this act shall be limited to the appropriation for such agency
13 and funds made available by law for the support of such appropriations; and
14 the restrictions of the State Procurement Law, the General Accounting and
15 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
16 Procedures and Restrictions Act, or their successors, and other fiscal
17 control laws of this State, where applicable, and regulations promulgated by
18 the Department of Finance and Administration, as authorized by law, shall be
19 strictly complied with in disbursement of said funds.

20
21 SECTION 7. LEGISLATIVE INTENT. It is the intent of the General
22 Assembly that any funds disbursed under the authority of the appropriations
23 contained in this act shall be in compliance with the stated reasons for
24 which this act was adopted, as evidenced by the Agency Requests, Executive
25 Recommendations and Legislative Recommendations contained in the budget
26 manuals prepared by the Department of Finance and Administration, letters, or
27 summarized oral testimony in the official minutes of the Arkansas Legislative
28 Council or Joint Budget Committee which relate to its passage and adoption.

29
30 SECTION 8. EMERGENCY CLAUSE. It is found and determined by the General
31 Assembly, that the Constitution of the State of Arkansas prohibits the
32 appropriation of funds for more than a one (1) year period; that the
33 effectiveness of this Act on July 1, 2014 is essential to the operation of
34 the agency for which the appropriations in this Act are provided, and that in
35 the event of an extension of the legislative session, the delay in the
36 effective date of this Act beyond July 1, 2014 could work irreparable harm

1 upon the proper administration and provision of essential governmental
2 programs. Therefore, an emergency is hereby declared to exist and this Act
3 being necessary for the immediate preservation of the public peace, health
4 and safety shall be in full force and effect from and after July 1, 2014.
