8	TO AUTHORIZE THE INTRODUCTION OF A NONAPROPRIATION

15	TO AUTHORIZE THE INTRODUCTION OF A
16	NONAPROPRIATION BILL CONCERNING DELAYING
17	THE IMPLEMENTATION OF COMMON CORE; AND TO
18	DECLARE AN EMERGENCY.

21	BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE EIGHTY-NINTH GENERAL
22	ASSEMBLY OF THE STATE OF ARKANSAS:
23	
24	THAT Representative Alexander is authorized to introduce a bill which
25	as introduced will read substantially as follows:
26	
27	"For An Act To Be Entitled
28	AN ACT TO DELAY THE IMPLEMENTATION OF COMMON CORE; TO DECLARE AN EMERGENCY;
29	AND FOR OTHER PURPOSES.

31	Subtitle
32	TO DELAY THE IMPLEMENTATION OF COMMON CORE; TO DECLARE AN EMERGENCY.
33	
34	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

36	SECTION 1. Arkansas Code Title 6, Chapter 15, Subchapter 1, is amended

1	to add an additional section to read as follows:
2	6-15-103. Legislative intent - Prohibition on the use of funding for
3	the Common Core State Standards Initiative.
4	(a) The purpose of this section is to place a moratorium on the
5	implementation of the Common Core State Standards Initiative and all related
6	activities and programs until January 1, 2017.
7	(b) A state agency, school district, public school, or education
8	service cooperative shall not expend state, federal, or local funds on
9	materials, programs, activities, or assessments that are intended to
10	implement or advance the Common Core State Standards Initiative, the
11	Partnership for the Assessment of Readiness for College and Careers, or any
12	organization with a similar mission, including without limitation:
13	(1) An organization promoting any national standards such as the
14	Next Generation Science Standards and the Future of Sex Education Initiative;
15	(2) Educational materials, textbooks, media, and other forms of
16	instructional materials that incorporate the Common Core State Standards
17	Initiative such as material from TERC Investigations Mathematics Curriculum
18	and Pearson Education materials;
19	(3) Training for public school employees on any topic related to
20	the Common Core State Standards Initiative or any initiative promoting
21	national standards;
22	(4) Student data collection of any data that was not collected
23	before the 2011-2012 school year; and
24	(5) An assessment, field test, or pilot project that was not
25	used in the state during or before the 2011-2012 school year that
26	incorporates the testing of any national standards, such as the Partnership
27	for the Assessment of Readiness for College and Careers, the Smarter Balanced
28	Assessment Consortium, the American Institutes for Research, or the
29	Educational Planning and Assessment System.
30	
31	SECTION 2. EMERGENCY CLAUSE. It is found and determined by the
32	General Assembly of the State of Arkansas that there is little understanding
33	of the Common Core State Standards Initiative; that the initiative may in
34	fact be harmful to the educational efforts and gains made by the state over
35	the past decade; and that this act is immediately necessary to prevent the
36	state's control over the education of its citizens from being marginalized.

1	inerefore, an emergency is declared to exist, and this act being immediately
2	necessary for the preservation of the public peace, health, and safety shall
3	become effective on:
4	(1) The date of its approval by the Governor;
5	(2) If the bill is neither approved nor vetoed by the Governor,
6	the expiration of the period of time during which the Governor may veto the
7	bill; or
8	(3) If the bill is vetoed by the Governor and the veto is
9	overridden, the date the last house overrides the veto."
