AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES
AND OPERATING EXPENSES FOR THE AUDITOR OF STATE
OPERATIONS AND UNCLAIMED PROPERTY PROGRAM FOR THE
FISCAL YEAR ENDING JUNE 30, 2015; AND FOR OTHER
PURPOSES.

AN ACT FOR THE AUDITOR OF STATE -
OPERATIONS AND UNCLAIMED PROPERTY PROGRAM
APPROPRIATION FOR THE 2014-2015 FISCAL
YEAR.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. REGULAR SALARIES - OPERATIONS. There is hereby established
for the Auditor of State for the 2014-2015 fiscal year, the following maximum

 14 the Auditor of State for the 2014-2015 fiscal year, the following maximum
 15 number of part-time or temporary employees, to be known as "Extra Help",
 16 payable from funds appropriated herein for such purposes: fifteen (15)
 17 temporary or part-time employees, when needed, at rates of pay not to exceed
 18 those provided in the Uniform Classification and Compensation Act, or its
 19 successor, or this act for the appropriate classification.

21 SECTION 3. APPROPRIATION - OPERATIONS. There is hereby appropriated,
 22 to the Auditor of State, to be payable from the State Central Services Fund,
 23 for personal services and operating expenses of the Auditor of State -

 There is hereby appropriated, to the Auditor of State, to be payable from
 cash funds as defined by Arkansas Code 19-4-801 of the Auditor of State, for
 operating expenses and the payment of claims by the Auditor of State -
 Unclaimed Property Program for the fiscal year ending June 30, 2015, the
 following:

SECTION 7. APPROPRIATION - PAYMENT OF UNCLAIMED MINERAL PROCEEDS -
 CASH. There is hereby appropriated, to the Auditor of State, to be payable
 from cash funds as defined by Arkansas Code 19-4-801 of the Auditor of State,
 for operating expenses and the payment of claims for abandoned mineral
 proceeds by the Auditor of State for the fiscal year ending June 30, 2015,
 the following:

SECTION 8. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER
 PROVISION. After receiving approval from the Chief Fiscal Officer of the
 State, and prior review by the Arkansas Legislative Council, the Auditor of
 State is authorized to transfer appropriation from any line item authorized
 in Section 3 Operations to any other line item authorized in Section 3 and
 the Agency is authorized to transfer appropriation from any line item
 authorized in Section 5 Unclaimed Property to any other line item authorized

1 in Section 5.

2 The provisions of this section shall be in effect only from July 1, ~~2013~~
3 2014 through June 30, ~~2014~~ 2015.

5 SECTION 9. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
6 authorized by this act shall be limited to the appropriation for such agency
7 and funds made available by law for the support of such appropriations; and
8 the restrictions of the State Procurement Law, the General Accounting and
9 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
10 Procedures and Restrictions Act, or their successors, and other fiscal
11 control laws of this State, where applicable, and regulations promulgated by
12 the Department of Finance and Administration, as authorized by law, shall be
13 strictly complied with in disbursement of said funds.

15 SECTION 10. LEGISLATIVE INTENT. It is the intent of the General
16 Assembly that any funds disbursed under the authority of the appropriations
17 contained in this act shall be in compliance with the stated reasons for
18 which this act was adopted, as evidenced by the Agency Requests, Executive
19 Recommendations and Legislative Recommendations contained in the budget
20 manuals prepared by the Department of Finance and Administration, letters, or
21 summarized oral testimony in the official minutes of the Arkansas Legislative
22 Council or Joint Budget Committee which relate to its passage and adoption.

24 SECTION 11. EMERGENCY CLAUSE. It is found and determined by the
25 General Assembly, that the Constitution of the State of Arkansas prohibits
26 the appropriation of funds for more than a one (1) year period; that the
27 effectiveness of this Act on July 1, 2014 is essential to the operation of
28 the agency for which the appropriations in this Act are provided, and that in
29 the event of an extension of the legislative session, the delay in the
30 effective date of this Act beyond July 1, 2014 could work irreparable harm
31 upon the proper administration and provision of essential governmental
32 programs. Therefore, an emergency is hereby declared to exist and this Act
33 being necessary for the immediate preservation of the public peace, health
34 and safety shall be in full force and effect from and after July 1, 2014.
