2	appropriated, to the Arkansas Commission on Law Enforcement Standards and

15	SECTION 6. APPROPRIATION - BENEFICIARIES OF FALLEN LAW ENFORCEMENT
16	OFFICERS. There is hereby appropriated, to the Arkansas Commission on Law
17	Enforcement Standards and Training, to be payable from the Fallen Law
18	Enforcement Officers' Beneficiary Fund, for personal services, operating
19	expenses and grants to provide support and assistance to beneficiaries of
20	fallen law enforcement officers for the fiscal year ending June 30, 2015, the
21	sum of\$25,000.

23	SECTION 7. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
24	CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CARRY
25	FORWARD. Any unexpended balances of funds authorized for Capital Outlay in
26	Section 2 of this Act on June 30, 2013 2015, shall be carried forward and
27	made available for the same purpose during the fiscal year ending June 30,
28	<del>2014</del> <u>2016</u> .
29	Any carry forward of unexpended balance of funding as authorized herein, may
30	be carried forward under the following conditions:
31	(1) Prior to June $30, \frac{2013}{2015}$ , the Agency shall by written statement set
32	forth its reason(s) for the need to carry forward said funding to the
33	Department of Finance and Administration Office of Budget;
34	(2) The Department of Finance and Administration Office of Budget shall
35	report to the Arkansas Legislative Council all amounts carried forward from
36	the first fiscal year of the biennium to the second fiscal year of the

- l biennium by the September Arkansas Legislative Council or Joint Budget
- 2 Committee meeting in the second fiscal year of the biennial period which
- 3 report shall include the name of the Agency, Board, Commission or Institution
- 4 and the amount of funding carried forward from the first fiscal year to the
- 5 second fiscal year, the program name or line item, the funding source and a
- 6 copy of the written request set forth in (1) above;
- 7 (3) Each Agency, Board, Commission or Institution shall provide a written
- 8 report to the Arkansas Legislative Council or Joint Budget Committee
- 9 containing all information set forth in item (2) above, along with a written
- 10 statement as to the current status of the project, contract, purpose etc. for
- 11 which the carry forward was originally requested no later than thirty (30)
- 12 days prior to the time the Agency, Board, Commission or Institution presents
- 13 its budget request to the Arkansas Legislative Council/Joint Budget
- 14 Committee; and
- 15 (4) Thereupon, the Department of Finance and Administration shall include
- 16 all information obtained in item (3) above in the budget manuals and/or a
- 17 statement of non-compliance by the Agency, Board, Commission or Institution.

19 SECTION 8. COMPLIANCE WITH OTHER LAWS. Disbursement of funds

20 authorized by this act shall be limited to the appropriation for such agency

21 and funds made available by law for the support of such appropriations; and

22 the restrictions of the State Procurement Law, the General Accounting and

- 23 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
- 24 Procedures and Restrictions Act, or their successors, and other fiscal
- 25 control laws of this State, where applicable, and regulations promulgated by
- 26 the Department of Finance and Administration, as authorized by law, shall be
- 27 strictly complied with in disbursement of said funds.

- 29 SECTION 9. LEGISLATIVE INTENT. It is the intent of the General
- 30 Assembly that any funds disbursed under the authority of the appropriations
- 31 contained in this act shall be in compliance with the stated reasons for
- 32 which this act was adopted, as evidenced by the Agency Requests, Executive
- 33 Recommendations and Legislative Recommendations contained in the budget
- 34 manuals prepared by the Department of Finance and Administration, letters, or
- 35 summarized oral testimony in the official minutes of the Arkansas Legislative
- 36 Council or Joint Budget Committee which relate to its passage and adoption.

2	SECTION 10. EMERGENCY CLAUSE. It is found and determined by the
3	General Assembly, that the Constitution of the State of Arkansas prohibits
4	the appropriation of funds for more than a one (1) year period; that the
5	effectiveness of this Act on July 1, 2014 is essential to the operation of
6	the agency for which the appropriations in this Act are provided, and that in
7	the event of an extension of the legislative session, the delay in the
8	effective date of this Act beyond July 1, 2014 could work irreparable harm
9	upon the proper administration and provision of essential governmental
10	programs. Therefore, an emergency is hereby declared to exist and this Act
11	being necessary for the immediate preservation of the public peace, health
12	and safety shall be in full force and effect from and after July 1, 2014.
