20	BE IT RESOLVED BY THE SENATE OF THE EIGHTY-NINTH GENERAL ASSEMBLY OF THE
21	STATE OF ARKANSAS:
22	
23	WHEREAS, Arkansas currently enjoys electricity prices that are
24	significantly below the national average price of electricity; and
25	
26	WHEREAS, Arkansas has benefited from a diverse mix of electricity
27	sources that includes coal, nuclear, natural gas, renewable resources,
28	and other sources; and
29	
30	WHEREAS, maintaining a diverse, reliable, and affordable
31	electricity supply is vital to Arkansas's economic growth, jobs, and
32	the overall well-being of its citizens; and
33	
34	WHEREAS, on June 2, 2014, the United States Environmental
35	Protection Agency (EPA) issued proposed guidelines limiting carbon
36	dioxide emissions from fossil fuel-fired power plants in Arkansas and



1 other states under § 111(d) of the Clean Air Act; and 2 3 WHEREAS, EPA's proposal requires the State of Arkansas to reduce 4 the carbon dioxide emissions rate of its electric generating fleet by 5 more than forty percent (40%), the sixth-largest emission reduction 6 requirement of any state; and 7 8 WHEREAS, EPA's proposal is based on emission-reduction measures 9 that directly involve the regulation of electricity, which is the 10 prerogative of the states; and 11 12 WHEREAS, EPA's proposal will have a major impact on the electric 13 ratepayers of Arkansas, especially low-income and middle-income 14 families, and the economy of the State of Arkansas, 15 16 NOW THEREFORE, BE IT RESOLVED BY THE SENATE OF THE EIGHTY-NINTH 17 GENERAL ASSEMBLY OF THE STATE OF ARKANSAS: 18 19 THAT the Senate finds that EPA's proposed guidelines for reducing 20 carbon dioxide emissions from fossil fuel-fired power plants under § 21 111(d) of the Clean Air Act interfere with the sovereign power of the 22 State of Arkansas to regulate electricity and to determine the mix of 23 energy resources that ensures reliable and affordable supplies of 24 electricity for its citizens. The Senate urges the Governor, the 25 Attorney General, the Arkansas Public Service Commission, and the 26 Arkansas Department of Environmental Quality to provide comments to EPA 27 regarding the proposed guidelines and the adverse impacts of EPA's 28 proposal on the economy of Arkansas and its citizens. 29 30 BE IT FURTHER RESOLVED that the Senate urges EPA to withdraw the 31 proposed guidelines for reducing carbon dioxide emissions from fossil fuel-fired power plants under § 111(d) of the Clean Air Act and propose 32 new guidelines that respect the primacy of the State of Arkansas to 33 34 determine the emission reduction requirements that are in the best 35 interest of its citizens.
