CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. USES OF APPROPRIATION. The funds appropriated in this Act shall be used to defray the expenses of the House of Representatives of the Legislative Session of the Eighty-Ninth Ninetieth General Assembly, and upon adjournment of the Legislative Session, any unexpended balance of the funds appropriated in this Act may be used to defray the necessary expenses of the operation of the Office of the Speaker of the House of Representatives, the Office of the Chief of Staff, the Office of the Coordinator of House Legislative Services, the Office of Parliamentarian, the Chief Clerk's Office, House Constituency Services Office and other reasonable and necessary expenses of the House of Representatives of the Eighty-Ninth Ninetieth General Assembly incurred during the interim between the adjournment of the Legislative Session of the Eighty-Ninth Ninetieth General Assembly and July 1, 2013 2015.

Additionally, if it is determined by the Speaker of the House that the presence, assistance, oversight and expertise of any House member is needed in the interim between the legislative sessions, and if it is determined by the Speaker of the House that certain expenses and per diem of members of the House should be paid by the House, such expenses and per diem at the rate authorized for attending legislative sessions shall be paid from the funds appropriated herein for Maintenance, Operations and Expenses.

SECTION 4. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. LEVELS. The Speaker of the House of Representatives and the Chief of Staff or his designee shall, during the month of June, each fiscal year, meet and determine the actual salaries to be paid each employee beginning the following July 1. Such salaries of the employees will be based upon an

| 5 | SECTION 5. EMERGENCY CLAUSE. It is found and determined by the General |
| 6 | Assembly, that the House of Representatives of the 90th General Assembly |
| 7 | convenes in Regular Session on January 12, 2015; that expenses of the session |
| 8 | begin immediately; and that the expenses are a just expense of the state |
| 9 | which must be paid at the time the services are provided. Therefore, an |
