12	contract that violates a provision of subsection (b) of this section is void
13	and unenforceable.
14	(2) This subsection shall not affect another provision of a
15	production contract, including a contract or related document, policy, or
16	agreement that can be given effect without the voided provision.

18	SECTION 2. Arkansas Code Title 4, Chapter 86, Subchapter 1, is amended
19	to add an additional section to read as follows:
20	4-86-110. Additional investment for production contracts.
21	(a) For purposes of this section, "production contract" means the same
22	<u>as defined in § 2-32-201.</u>
23	(b) A mortgage broker or loan originator on behalf of a mortgage
24	broker shall provide the following notice in boldface in or attached to a
25	commercial mortgage agreement if the mortgagee is obtaining financing
26	relating to a production contract: "NOTICE: The Mortgagee may be required to
27	make additional investments to comply with the related production contract
28	before the term of this mortgage is complete."
