9 SECTION 5. COMPLIANCE WITH OTHER LAWS. Disbursement of funds 10 authorized by this act shall be limited to the appropriation for such agency 11 and funds made available by law for the support of such appropriations; and 12 the restrictions of the State Procurement Law, the General Accounting and 13 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary 14 Procedures and Restrictions Act, the Higher Education Expenditures 15 Restrictions Act, or their successors, and other fiscal control laws of this 16 State, where applicable, and regulations promulgated by the Department of 17 Finance and Administration, as authorized by law, shall be strictly complied 18 with in disbursement of said funds.

20 SECTION 6. LEGISLATIVE INTENT. It is the intent of the General 21 Assembly that any funds disbursed under the authority of the appropriations 22 contained in this act shall be in compliance with the stated reasons for 23 which this act was adopted, as evidenced by the Agency Requests, Executive 24 Recommendations and Legislative Recommendations contained in the budget 25 manuals prepared by the Department of Finance and Administration, letters, or 26 summarized oral testimony in the official minutes of the Arkansas Legislative 27 Council or Joint Budget Committee which relate to its passage and adoption. 28

SECTION 7. EMERGENCY CLAUSE. It is found and determined by the General 29 30 Assembly, that the Constitution of the State of Arkansas prohibits the 31 appropriation of funds for more than a one (1) year period; that the 32 effectiveness of this Act on July 1, 2015 is essential to the operation of 33 the agency for which the appropriations in this Act are provided, and that in 34 the event of an extension of the legislative session, the delay in the effective date of this Act beyond July 1, 2015 could work irreparable harm 35 36 upon the proper administration and provision of essential governmental
