7	courts of the Forty-First Judicial District as of January 1, 2021.		
8	(a)(1) Beginning January 1, 2021, the cities and counties of the		
9	Forty-First Judicial District that are currently served by local district		
10	courts under § 16-17-901 et seq. shall be reorganized into a state district		
11	court district and served by state district court judges as provided in		
12	subsection (b) of this section.		
13	(2) The new state district court judgeships created in the		
14	Forty-First Judicial District by this section shall become effective January		
15	1, 2021, and shall be placed on the ballot to be elected in the 2020		
16	nonpartisan judicial election from the newly constructed state district court		
17	district.		
18	(3) The cities and counties of the Forty-First Judicial District		
19	that were previously served by local district courts and will be served by a		
20	state district courts shall comply with the cost-sharing requirements		
21	established in § 16-17-1106, effective January 1, 2021.
