2	published by the Department of Education under § 6-13-1602(2) may annually		
3	request a waiver from the average daily membership requirement of three		
4	hundred fifty (350) students from the State Board of Education.		
5	(2) A school district shall submit a petition for a waiver to		
6	the state board no later than thirty (30) days after the consolidation list		
7	is published.		
8	(3) The petition for a waiver shall include:		
9	(A) The average daily membership of the school district in		
10	the current school year;		
10	(B) A statement that the school district has not been
