1 (b)(1) The county clerk, upon receipt of the certification of the 2 administration of the oath prescribed for a director, shall immediately 3 commission such persons, and they shall enter at once upon their duties as 4 directors. 5 (2) By the close of business of the day following the receipt of 6 the certification of the administration of the oath, the county clerk or his 7 or her designee shall notify the superintendent of the school district by 8 phone that the individual has sworn to the director's oath and shall send a 9 copy of the certificate of the administration of the oath to the school district central office within five (5) days. 10 11 (c) The failure of an elected director to have the oath administered 12 as required under subsection (a) of this section will result in: 13 (1) The individual not being qualified to serve for the purpose of Arkansas Constitution, Article 19, § 5; and 14 15 (2) A holdover. 16 17 SECTION 3. Arkansas Code § 6-14-115(a), concerning school elections, 18 is amended to add an additional subdivision to read as follows: 19 (2) The county clerk or his or her designee shall deliver to the 20 person having the highest number of legal votes: (A) A certificate of election; 21 22 (B) Notice of the requirement for all directors elected to 23 an initial or nonconsecutive term that he or she must subscribe to the 24 director's oath under § 6-13-617; 25 (C) The date the ten (10) days to have the oath 26 administered expires; 27 (D) A list of the individuals qualified to give the oath 28 under § 21-2-105; 29 (E) A copy of the director's oath with spaces for the 30 date, the signature of the director, and the signature of the administrator of the oath; and 31 32 (F) Notice that the individual shall be unable to assume 33 the duties of a director until a copy of the administration of the oath is 34 received by the county clerk or his or her designee. 35
