25	BE IT ENACTED BY THE GENERA	L ASSEMBLY OF THE STATE O	F ARKANSAS:

27	SECTION 1. Arkansas	Code § 2-36-306(a), conce	rning the North Central	
28	Arkansas District Fair and	Livestock Show, is amende	d to read as follows:	
29	(a) There is establi	shed a district livestock	show to be known as the	
30	"North Central Arkansas Dis	trict Fair and Livestock	Show" and to be located	
31	in Izard County.

33	SECTION 2. Arkansas	Code § 2-36-306, concerni	ng the North Central	
34	Arkansas District Fair and	Livestock Show, is amende	d to add an additional	
35	subsection to read as follo	ws:		
36	(e)(l) The board sha	11 determine the location	of the North Central	

1	Arkansas District Fair and Livestock Show by a vote of two-thirds (2/3) of		
2	the members of the board.		
3	(2) However, the North Central Arkansas District Fair and		
4	Livestock Show shall be located in one (1) of the counties of the district.		
5			
6	SECTION 3. EMERGENCY CLAUSE. It is found and determined by the		
7	General Assembly of the State of Arkansas that agriculture is an essential		
8	part of Arkansas's economy; that the ability to show livestock at district		
9	fairs and livestock shows educates young citizens of the state about the		
10	importance of agriculture and encourages these young people to become members		
11	of the state's agricultural community; that it is in the state's interest to		
12	encourage future members of the agricultural community who will support and		
13	sustain this critical element of Arkansas's economy; that there are		
14	difficulties in executing a contract for the existing location for the North		
15	Central Arkansas District Fair and Livestock Show; that without a contract		
16	for the location, the fair will cease to exist and many young people will		
17	miss out on the opportunities presented by the fair; and that this act is		
18	immediately necessary because the potential for future generations of		
19	Arkansas farmers and members of the agricultural community will be negatively		
20	impacted if the North Central Arkansas District Fair and Livestock Show		
21	ceases to exist. Therefore, an emergency is declared to exist, and this act		
22	being immediately necessary for the preservation of the public peace, health,		
23	and safety shall become effective on the tenth day following:		
24	(1) The date of its approval by the Governor;		
25	(2) If the bill is neither approved nor vetoed by the Governor,		
26	the expiration of the period of time during which the Governor may veto the		
27	bill; or		
28	(3) If the bill is vetoed by the Governor and the veto is		
29	overridden, the date the last house overrides the veto.
