15	TO AMEND THE LAW CONCERNING THE
16	ORGANIZATION AND OPERATION OF A QUORUM

20	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21	
22	SECTION 1. Arkansas Code § 14-14-904(a), concerning the time and place
23	of quorum court assembly, is amended to read as follows:
24	(a) Time and Place of Quorum Court Assembly.
25	(1)(A)(i) The justices of the peace elected in each county shall
26	assemble and organize as a county quorum court body on the first regular
27	meeting date after the beginning of the justices' term in office, or
28	(ii) Alternatively, the county judge may schedule
29	the biennial meeting date of the quorum court on a date in January other than
30	the first regular meeting date of the quorum court after the beginning of the
31	justices' term.
32	(ii) At the first regular meeting, the quorum court
33	shall establish the date, time, and location of meetings of the quorum court.
34	(iii) The organizational ordinance adopted at the
35	first regular meeting of the quorum court shall be effective upon adoption.
36	(B) Thereafter, the justices shall assemble each calendar

- 1 month at a regular time and place as established by ordinance and in their
- 2 respective counties to perform the duties of a quorum court, except that more
- 3 frequent meetings may be required by ordinance.
- 4 (2) By declaration of emergency or determination that an
- 5 emergency exists and the safety of the general public is at risk, the county
- 6 judge may change the date, place, or time of the regular meeting of the
- 7 quorum court upon twenty-four-hour notice.

- 9 SECTION 2. Arkansas Code § 14-14-904(d), concerning the presiding 10 officer of the quorum court, is amended to read as follows:
- 11 (d) Presiding Officer.
- 12 (1)(A) The county judge shall preside over the quorum court
- 13 without a vote but with the power of veto.
- 14 (B) In the absence of the county judge, a quorum of the
- 15 justices by majority vote shall elect one (1) of their number to preside but
- 16 without the power to veto.
- 17 (2)(A)(i) The presiding officer shall appoint all regular and
- 18 special committees of a quorum court, subject to any procedural rules that
- 19 may be adopted by ordinance and to approval by majority vote of the quorum
- 20 court.
- 21 <u>(ii)(a) The quorum court may create additional</u>
- 22 regular and special committees of the quorum court in the organizational
- 23 ordinance, with the appointment of committee members made by the presiding
- 24 officer under subdivision (d)(2)(A)(i) of this section.
- 25 <u>(b) If the presiding officer has not made the</u>
- 26 appointments of a regular or special committee created by the quorum court
- 27 under subdivision (d)(2)(A)(ii)(a) of this section within sixty (60) days of
- 28 the first regular meeting of the quorum court, the quorum court may make the
- 29 <u>appointments by majority vote.</u>
- 30 (B) A regular committee or special committee of the quorum
- 31 court shall not consist of more than a quorum of the whole body without the
- 32 consent of the county judge.

- 34 SECTION 3. Arkansas Code § 14-14-904(e), concerning procedural rules
- 35 and attendance at meetings, is amended to read as follows:
- 36 (e) Procedural Rules and Attendance at Meetings.

1	(1) Except as otherwise provided by law, the quorum court of
2	each county shall determine at the first regular meeting its rules of
3	procedure, whether by Robert's Rules of Order or otherwise, and may compel
4	the attendance of absent members in such manner and under such penalties as
5	may be prescribed by ordinance.
6	(2) The determination of rules of procedure under subdivision
7	(e)(1) of this section shall be made at the first regular meeting of the
8	quorum court in its organizational ordinance.
