27	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

29	SECTION 1. Arkansas Code § 12-27-114(c), concerning the rules adopted
30	by the Board of Corrections to reimburse a county jail for housing a state
31	inmate, is amended to read as follows:
32	(c)(1) The Board of Corrections shall adopt regulations rules by which
33	the Department of Correction or the Department of Community Correction may
34	reimburse any county, which is required to retain an inmate awaiting delivery
35	to the custody of either the Department of Correction or the Department of
36	Community Correction for more than thirty (30) days upon receipt of a correct

1	sentencing order, for the actual costs paid for any emergency medical care
2	for physical injury or illness of the inmate retained under this section if
3	the injury or illness is directly related to the incarceration and the county
4	is required by law to provide the care for inmates in the jail.
5	(2) The Director of the Department of Correction or his or her
6	designee or the Director of the Department of Community Correction or his or
7	her designee may accept custody of any inmate as soon as possible upon
8	request of the county upon determining that the inmate is required to have
9	extended medical care.
10	(3)(A) Reimbursements for medical expenses shall require prior
11	approval of the Department of Correction or the Department of Community
12	Correction before the rendering of health care.
13	(B)(i) In a true emergency situation, health care may be
14	rendered without prior approval.
15	(ii) The Department of Correction or the Department
16	of Community Correction shall be notified of a true emergency situation
17	immediately after the true emergency situation
