It is found and determined by the General 27 Assembly of the State of Arkansas that various laws have been enacted since 28 29 the passage of the Revenue Classification Law which have changed or created 30 various revenues collected by the State, and that this amendment to the 31 Revenue Classification Law is necessary in order to reflect the various taxes, licenses, fees and other revenues levied and collected for the support 32 33 of and use by State Government as they currently exist and from which 34 appropriations which become effective July 1, 2015 have been made by the Ninetieth General Assembly. Therefore, an emergency is declared to exist and 35 36 this act being immediately necessary for the preservation of the public
