20	DEPENDENCY-NEGLECT CASES; TO KEEP

23	LITEM WITH BETTER TOOLS FOR RESOLVING

27	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
28	
29	SECTION 1. Arkansas Code § 9-27-310(b)(2), concerning petitions to
30	commence dependency-neglect of proceedings, is amended to read as follows:
31	(2) Only a law enforcement officer, prosecuting attorney, or the
32	Department of Human Services or its designee, or a dependency-neglect
33	attorney ad litem employed by or contracting with the Administrative Office
34	of the Courts may file a dependency-neglect petition seeking ex parte
35	emergency relief.

1 SECTION 2. Arkansas Code § 9-27-310, concerning the commencement of 2 juvenile proceedings, is amended to add an additional subsection to read as follows: 3 4 (g) An attorney ad litem appointed under § 12-18-1001(e) shall review 5 all relevant information from the juvenile proceeding regarding the child or 6 children for whom protective custody was taken and shall file any pleadings 7 that may be necessary to protect the health, safety or welfare of the child 8 or children. 9 10 SECTION 3. Arkansas Code § 9-27-311(a), concerning the required 11 contents of a dependency-neglect petition, is amended to read as follows: 12 (a) The petition shall set forth the following: 13 (1)(A) The name, address, gender, social security number, and 14 date of birth of each juvenile subject of the petition. 15 (B) A single petition for dependency-neglect or family in 16 need of services shall be filed that includes all siblings who are subjects 17 of the petition; 18 (2) The name and address of each of the parents or the surviving 19 parent of the juvenile or juveniles; 20 (3) The name and address of the person, agency, or institution 21 having custody of the juvenile or juveniles; 22 (4) The name and address of any other person, agency, or 23 institution having a claim to custody or guardianship of the juvenile or 24 juveniles; 25 (5) In a proceeding to establish paternity, the name and address 26 of both the putative father and the presumed legal father, if any; and 27 (6) In a dependency-neglect proceeding, the name and address of 28 a putative parent, if any; and 29 (7) In a dependency-neglect proceeding: 30 (A) The name, address, gender, and date of birth of any sibling of a juvenile named as respondent to the petition; and 31 32 (B) The name of each parent, guardian or custodian of a 33 sibling of a juvenile named as respondent to the petition.

SECTION 4. Arkansas Code § 9-27-311(c), concerning the required contents of a dependency-neglect petition, is amended to read as follows:

1 (c)(1) All persons named in subdivisions (a)(1)-(3) of this section 2 and subdivision (a)(6) of this section shall be made defendants and served as 3 required by this subchapter. 4 (2) However: 5 (A) In all paternity actions, the petitioner shall be 6 required to name as defendants only the mother, the putative father, and the presumed legal father, if any; and 7 8 (B) In dependency-neglect petitions the juvenile shall not 9 be named as a defendant but shall have party status and be named in the 10 petition as a respondent and shall be served as a party defendant under § 9-11 27-312. 12 13 SECTION 5. Arkansas Code § 9-27-311(d)(2), concerning the required 14 contents of a dependency-neglect petition, is amended to add additional 15 subdivisions to read as follows: 16 (C) The supporting affidavit of facts shall include known 17 information regarding the fitness of the noncustodial parent to be considered for custody, placement, or visitation with the juvenile. 18 19 (D) If the petition for dependency-neglect is filed by the 20 Department of Human Services, the supporting affidavit of facts shall include 21 a list of all contact the department has had with the family before the 22 filing of the petition, including without limitation hotline calls accepted 23 for maltreatment, investigations, and open cases. 24 25 SECTION 6. Arkansas Code § 9-27-316(f)(4), concerning the right to 26 counsel in delinquency and family in need of services cases, is amended to 27 read as follows: 28 (4) An attorney ad litem shall be provided access to all records 29 relevant to the juvenile's case, including, but not limited to, school records, medical records, all court records relating to the juvenile and his 30 31 or her family, and records, including those maintained electronically and in the Children's Reporting and Information System, of the Department of Human 32 Services <u>relating to the juvenile and his or her family</u> to the extent 33 permitted by federal law. 34

SECTION 7. Arkansas Code § 9-27-316(g)(4), concerning the right to

- 1 counsel in delinquency and family in need of services cases, is amended to 2 read as follows:
- 3 (4) Upon presentation of an order of appointment, a court-4 appointed special advocate shall be provided access to all records relevant
- 5 to the juvenile's case, including, but not limited to, school records,
- 6 medical records, all court records relating to the juvenile and his or her
- 7 family, and department records, <u>including those maintained electronically and</u>
- 8 in the Children's Reporting and Information System, to the extent permitted
- 9 by federal law.

10

- 11 SECTION 8. Arkansas Code 9-27-316(h)(1), concerning the right to
- 12 counsel in delinquency and family in need of services cases, is amended to
- 13 add an additional subdivision to read as follows:
- 14 <u>(E) In a dependency-neglect proceeding naming a minor</u>
- 15 parent as a defendant, the court shall appoint a qualified parent counsel for
- 16 the minor parent.

- SECTION 9. Arkansas Code § 9-27-316(h)(7), concerning the right to
- 19 counsel in delinquency and family in need of services cases, is amended to
- 20 read as follows:
- 21 (7) The attorney for the parent or custodian shall be provided
- 22 access to all records relevant to the juvenile's case, including without
- 23 limitation school records, medical records, all court records relating to the
- 24 juvenile and his or her family, and department records relating to the
- 25 <u>juvenile and his or her family, including those maintained electronically and</u>
- 26 <u>in the Children's Reporting and Information System</u>, to which the parent or
- 27 custodian is entitled under state and federal law.

28

- 29 SECTION 10. Arkansas Code § 9-27-327(a), concerning dependency-neglect
- 30 adjudication hearings, is amended to read as follows:
- 31 (a)(1) An adjudication hearing shall be held to determine whether the
- 32 allegations in a petition are substantiated by the proof.
- 33 (2)(A) If the court finds that the juvenile is dependent-
- 34 neglected, the court shall address whether a noncustodial parent contributed
- 35 to the dependency-neglect and whether the noncustodial parent is a fit parent
- 36 <u>for purposes of custody or visitation.</u>

1 (B) If the court determines that the child cannot safely 2 be placed in the custody of the noncustodial parent, the court shall make specific findings of fact regarding the safety factors that need to be 3 4 corrected by the noncustodial parent before placement or visitation with the 5 juvenile. 6 (3) Unless the court finds that a removal occurred due to an 7 emergency and the agency had no prior contact with the family or the child, 8 evidence shall be presented to the court regarding all prior contact between 9 the agency and the juvenile or the family before a finding of reasonable 10 efforts to prevent removal by the Department of Human Services. 11 (4) (4) A finding of reasonable efforts to prevent removal of 12 the juvenile is void if the court determines that the department failed to 13 disclose all prior contact between the agency and juvenile or the family 14 before the finding. 15 (2)(5)(A) The dependency-neglect adjudication hearing shall be 16 held within thirty (30) days after the probable cause hearing under § 9-27-17 315. 18 (B) On a motion of the court or any party, the court may 19 continue the adjudication hearing up to: 20 (A) Sixty sixty (60) days after the probable cause hearing <u>removal</u> for good cause shown; and 21 22 (B) Ninety (90) days after the probable cause hearing if 23 finding that necessary and relevant evidence cannot be obtained in a timely 24 manner. 25 (3)(6) If the juvenile has previously been adjudicated a dependent-neglected juvenile in the same case in which a motion for a change 26 27 of custody has been filed to remove the juvenile from the custody of a 28 parent, a subsequent adjudication is required if the ground for the removal 29 is not the same as the ground previously adjudicated. 30 31 SECTION 11. Arkansas Code § 9-27-361(a)(1), concerning court reports 32 for dependency-neglect review hearings, is amended to read as follows: 33 (a)(1) Seven (7) business days prior to before a scheduled dependency-34 neglect review hearing, including the fifteenth-month review hearing and any 35 post-termination of parental rights hearing, the Department of Human Services 36 and a court-appointed special advocate, if appointed, shall:

1	$\underline{(A)}$ <u>file</u> with the juvenile division of circuit court
2	a review report including a certificate of service that the report has been
3	distributed to all the parties or their attorneys and the court-appointed
4	special advocate, if appointed; or
5	(B) Upload into the court case management database an electronic
6	copy of the court report.
7	
8	SECTION 12. Arkansas Code § 9-27-361(a)(2), concerning court reports
9	for dependency-neglect review hearings, is amended to add an additional
10	subdivision to read as follows:
11	(D)(i) The department shall provide to all parties and the
12	court-appointed special advocate, if assigned to the case, copies of all
13	Children's Reporting and Information System contact screens, placement
14	screens completed, investigations, home studies, and comprehensive health
15	evaluations entered or received by the department since the last hearing, by:
16	(A) Providing physical copies as an attachment to the
17	court report; or
18	(B)(i) Uploading electronic copies into the court case
19	management database.
20	(ii) The department may redact specific addresses of
21	foster parents if it is in the best interest of the juveniles to do so and
22	information protected by state or federal law.
23	(iii) A party who inadvertently receives information
24	protected by state or federal law shall immediately notify the department and
25	shall not further disclose the information, including to a client.
26	
27	SECTION 13. Arkansas Code § 9-28-1003(a), concerning safeguards for
28	children in foster care, is amended to read as follows:
29	(a) Special safeguards, resources, and care should be provided to
30	children <u>involved in dependency-neglect cases who are</u> in foster care <u>or in an</u>
31	out-of-home placement because of the temporary or permanent separation from
32	parents.
33	
34	SECTION 14. Arkansas Code § 9-28-1003, concerning safeguards for
35	children in foster care, is amended to add additional subsections to read as

follows:

36

1	(c) Sibling relationships are recognized to be unique and separate
2	from the parent-child bond due to the similar history, heritage, culture and
3	biology of the siblings and sibling separation is a significant and distinct
4	loss that must be repaired by frequent and regular contact, continuity and
5	stability during a child's placement in foster care or an out-of-home
6	placement and each child has the right to know and be actively involved in
7	his or her sibling's lives absent extraordinary circumstances.
8	(d) In addition to the safeguards identified under subsection (b) of
9	this section, siblings in foster care or in an out-of-home placement in this
10	state are entitled to the following unless a court specifically finds that it
11	is not in the best interest of the child:
12	(1) To live together in the same placement;
13	(2) To be separated only after:
14	(A) An assessment by a mental health professional
15	determines that placement of the siblings together would be detrimental to
16	the health, safety or well-being of one (1) or more of the juveniles; or
17	(B) The department presents evidence to the court that
18	there are no available relevant placements near the county where the juvenile
19	resided before entering care;
20	(3) If separated, to be placed in close proximity to siblings in
21	order to facilitate frequent and meaningful contact;
22	(4) If separated, to have visitation with all siblings that
23	shall be:
24	(A) Regular and consistent;
25	(B) Include face-to-face meetings or alternate methods of
26	communication at least one (1) time per week when possible; and
27	(C) Outlined in the case plan and approved by the court;
28	(5) To be actively involved in each sibling's life and share
29	celebrations including birthdays, holidays, graduations, and meaningful
30	milestones;
31	(6) To attend extracurricular events of each sibling including
32	without limitation athletic events, musical performances, scouting
33	ceremonies, and church events;
34	(7) To be included in case plan staffing decisions and
35	permanency planning decisions regarding siblings;
36	(8) To be informed of the expectations for continued contact in

1	the event that a sibling is placed or adopted separate from the sibling;
2	(9) To be notified of a change of placement for a sibling;
3	(10) To be informed when a sibling is being discharged from
4	foster care;
5	(11) If a sibling leaves care, to be allowed to maintain contact
6	with a sibling who remains in an out-of-home placement;
7	(12) To be supported in efforts to maintain relationships with
8	siblings who are not in care or have been adopted or placed in permanent
9	custody or guardianship separate from the child;
10	(13) To not have visitation or contact with a sibling withheld
11	as a behavioral consequence unless there are documented safety concerns; and
12	(14) If separated, have the sibling's case reviewed by the court
13	at least one (1) time every ninety (90) days for an assessment of the
14	separation and to determine whether there has been a reasonable effort to
15	reunite the siblings and to allow contact between the siblings consistent
16	with this section.
17	(e) A minor who is the custodial parent of one (1) or more children
18	and who is placed in foster care shall be placed in the same placement as the
19	child unless the court has adjudicated the child or children of the minor
20	parent to be dependent-neglected and the court finds that it is not in the
21	best interest of the child or children to be placed in the same placement as
22	the minor parent.
23	
24	SECTION 15. Arkansas Code § 12-18-1001(b), concerning protective
25	custody of children generally, is amended to read as follows:
26	(b) However, custody shall not exceed seventy-two (72) hours except in
27	the event that the expiration of seventy-two (72) hours falls on a weekend or
28	holiday, in which case custody may be extended $\frac{1}{2}$ to the end of the next
29	business day following the weekend or holiday.
30	
31	SECTION 16. Arkansas Code § 12-18-1001, concerning protective custody
32	of children generally, is amended to add an additional subsections to read as
33	follows:
34	(c) If the department assesses the health and safety of a child and
35	determines that there is an immediate danger to the health or physical well-
36	heing of the child in the care custody or control of the legal parent

1	guardian, or custodian, the department shall place the child into protective
2	custody and shall not direct or allow the legal parent, guardian, or
3	custodian to place the child in the care, custody, or control of another
4	person.
5	(d) If the department assesses the health and safety of a child and
6	determines that the child cannot safely remain in the care, custody, or
7	control of the legal parent, guardian, or custodian without the
8	implementation of a protection plan, the department shall file a petition for
9	dependency-neglect.
10	(e) If protective custody is taken by a juvenile division circuit
11	court judge during juvenile proceedings concerning the child or a sibling of
12	the child, the court shall:
13	(1) Appoint a dependency-neglect attorney ad litem for the child
14	or children for whom protective custody was taken, and
15	(2) Designate a member of the court's staff, a party to the
16	juvenile case, or a juvenile officer to immediately provide a copy of the
17	order of appointment and all relevant information from the juvenile case to
18	the attorney ad litem appointed by the court.
