12	conducting the raffle or game of bingo.		
13	(b) No \underline{An} individual under eighteen (18) years of age \underline{may} \underline{shall} not:		
14	(1) play Play a game of bingo conducted by a licensed authorized		
15	organization; or		
16	(2) purchase raffle tickets Purchase a raffle ticket from a		
17	licensed authorized organization directly or through the mail, email, fax,		
18	telephone, or the website of the licensed authorized organization.
