22	SECTION 1. Arkansas Code § 12-9-115 is amended to read as follows:	
23	12-9-115. Training for constables — Requirements to become a certif	ied
24	law enforcement officer.	
25	(a) After consultation with the Arkansas Constables Association, th	ıe
26	Arkansas Commission on Law Enforcement Standards and Training shall develop	
27	voluntary training course of one hundred twenty (120) hours to one hundred	_
28	sixty (160) hours for certifying new constables.	
29	(b) A constable may choose to become a certified law enforcement	
30	officer if the following conditions are met:	
31	(1) The constable completes the training described under	
32	subsection (a) of this section;	
33	(2) The constable meets the minimum standards for law	
34	enforcement certification that are required of a new certified law	
35	enforcement officer as established by the commission; and	
36	(3) The constable successfully completes any additional train	ing

1	or education required of a new certified law enforcement officer under this
2	subchapter or as established by the commission by rule.
3	(c)(l) The commission may decertify a constable under this section if
4	the constable:
5	(A) Fails to successfully complete or maintain the
6	requirements under subsection (b) of this section; or
7	(B) Fails to comply with the requirements of § 14-14-1314.
8	(2) If the commission decertifies a constable under this
9	subsection, the constable:
10	(A) May not seek to become a certified law enforcement
11	officer under this section until after one (1) year has passed from the
12	decertification; and
13	(B) Shall be required to again complete the requirements
14	under subsection (b) of this section.
15	
16	SECTION 2. Arkansas Code § 14-14-1314, concerning training and uniform
17	requirements for constables, is amended to add an additional subsection to
18	read as follows:
19	(e)(1) A constable is not required to become a certified law
20	enforcement officer.
21	(2) However, a constable may become a certified law enforcement
22	officer if the constable satisfies the requirements of § 12-9-115(b).
