2	(a) A winery shall ship only a <u>within or without this state may ship</u>
3	vinous liquor to a private residence <u>in this state</u> .
4	(b) A winery may only ship one (l) case of vinous liquor per consumer
5	in any calendar quarter. Before shipping wine under subsection (a) of this
6	section, a winery shall make all reasonable efforts to ensure that the
7	recipient of the vinous liquor is twenty-one (21) years of age or older.
8	(c)(l) A shipment of a vinous liquor shall have a shipping label
9	provided by the Alcoholic Beverage Control Division affixed to the shipping
10	package.
11	(2) The fee for each label for a shipment shall not exceed ten
12	dollars (\$10.00).
