6	SECTION 3. EMERGENCY CLAUSE. It is found and determined by the		
7	General Assembly of the State of Arkansas that the state of Arkansas is		
8	experiencing a healthcare professional maldistribution resulting in medically		
9	underserved areas throughout the state; that allowing healthcare		
10	professionals to provided healthcare services through telemedicine will ease		
11	the burden on medically underserved areas; and that this act is immediately		
12	necessary because the citizens and healthcare professionals of Arkansas need		
13	immediate guidance concerning the law regarding healthcare services provided		
14	through telemedicine. Therefore, an emergency is declared to exist, and this		
15	act being immediately necessary for the preservation of the public peace,		
16	health, and safety shall become effective on:		
17	(1) The date of its approval by the Governor;		
18	(2) If the bill is neither approved nor vetoed by the Governor,		
19	the expiration of the period of time during which the Governor may veto the		
20	<u>bill; or</u>		
21	(3) If the bill is vetoed by the Governor and the veto is		
22	overridden, the date the last house overrides the veto.
