| 24 | SECTION 1. Arkansas Code § 27-70-207(c)(2), concerning the                    |
| 25 | distribution of highway revenues to cities and incorporated towns, is amended |

| 27 | (2)(A) The Treasurer of State shall on or before the tenth day next           |
| 28 | following the last day of each calendar month make distribution of the funds  |
| 29 | on the basis of population according to the most recent federal census, with  |
| 30 | the amount to be paid over to each city or incorporated town in the           |
| 31 | proportion that its population bears to the total population of all cities    |
| 32 | and towns.  |
| 33 | (B) A city or incorporated town may request a partial                         |
