25	federal laws or regulations.		
26	(B) "Expenditure data" does not include expenses of		
27	pending litigation <u>.</u>		
28	(C) "Expenditure data" includes copies of contingency fee		
29	contracts and payments of contingency fees under § 25-1-123;
