2	(b) After July 31, 2007, the <u>The</u> newly transferred license <u>to carry a</u>		
3	<u>concealed handgun in Arkansas</u> is valid for a period of five (5) years from		
4	the date of issuance and binds the holder to all Arkansas laws and		
5	regulations regarding the carrying of the concealed handgun.		
6	(c) When a person receives his or her license to carry a concealed		
7	handgun in Arkansas, he or she shall promptly surrender the out-of-state		
8	handgun carry license to the Department of Arkansas State Police unless that		
9	is impractical due to the out-of-state handgun carry license's integration		
10	with another government-issued document.

12	SECTION 2. Arkansas Code § 5-73-321 is amended to read as follows:		
13	5-73-321. Recognition of other states' licenses.		
14	A person <u>who is not an Arkansas resident and who is</u> in possession of a
