2	that neither house of the General Assembly may adjourn for more than three
3	(3) days without the consent of the other house; and

5	WHEREAS, the House of Representatives and the Senate of the Ninetieth
6	General Assembly wish to resume their work on Tuesday, January 20, 2015,

8	NOW THEREFORE,
9	BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE NINETIETH GENERAL
