23	WHEREAS, Judge Jacobs graduated from Clarksville High School in 1965
24	where he played basketball and football, and ran track; and he received a
25 26	full athletic scholarship to play football for the Razorbacks at the
20	University of Arkansas in Fayetteville, under head coach, Frank Broyles; and
28	WHEREAS, Judge Jacobs earned a bachelor's degree in marketing and went
29	on to pursue a position with Exxon Mobile in Lumberton, Texas; and he served
30	on the Lumberton School Board from 1975-76 during his eight (8) years in
31	Lumberton; and

33	WHEREAS, Judge Jacobs returned to Johnson County where he served as an
34	alderman on the Clarksville City Council before his tenure as county judge
35	from 1991-2014; and
