7	Upon application to the Department of Health in the form provided for		
8	the particular class of license applied for, accompanied by the required fee		
9	a person licensed as a cosmetologist, electrologist, manicurist,		
10	aesthetician, or instructor under the laws of another state shall be grante		
11	a license to practice the occupation or occupations in this state not of		
12	greater scope than the occupation or occupations for which the applicant was		
13	previously licensed in the other state, upon the following conditions:		
14	(1) That the applicant for a license as a cosmetologist,		
15	manicurist, or aesthetician is not less than eighteen (18) years of age, and		
16	the applicant for a license as an instructor or electrologist is not less		
17	than twenty-one (21) years of age;		
18	(2) That the applicant holds a current valid license upon		
19	application for reciprocity, evidenced by a certified copy of the license as		
20	an affidavit from the other state or by such other evidence as the departmen		
21	may require;
