20	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22	SECTION 1. Arkansas Code § 6-47-305(c), concerning the Distance	
23	Learning Coordinating Council, is amended to read as follows to remove a	
24	duplicate reference to the Department of Information Systems:	
25	(c) The coordinating council shall consist of the following members:	
26	(1) One (1) member who is an employee of the Department of	
27	Education appointed by the Commissioner of Education;	
28	(2) One (1) member who is an employee of the Arkansas	
29	Educational Television Network appointed by the Director of the Educational	
30	Television Division of the Department of Education;	
31	(3) One (1) member who is an employee of the Arkansas School fo	
32	Mathematics, Sciences, and the Arts appointed by the director Director of the	he
33	Arkansas School for Mathematics, Sciences, and the Arts;	
34	(4) One (1) member who is an employee of the Department of	
35	Information Systems appointed by the Director of the Department of	
36	Information Systems;	

1	(5) One (1) member who is an employee of the Department of
2	Information Systems appointed by the Director of the Department of
3	Information Systems;
4	(6) One (1) member who is an employee of the Arkansas Science
5	and Technology Authority appointed by the President of the Arkansas Science
6	and Technology Authority;
7	$\frac{(7)}{(6)}$ One (1) member who is an employee of the Department of
8	Career Education appointed by the Director of the Department of Career
9	Education;
10	$\frac{(8)}{(7)}$ One (1) member who is employed by the Department of
11	Higher Education appointed by the Director of the Department of Higher
12	Education;
13	$\frac{(9)(8)}{(8)}$ One (1) member who is an employee of the Arkansas State
14	Library appointed by the State Librarian;
15	$\frac{(10)}{(9)}$ One (1) member who is an employee of an education
16	service cooperative appointed by the Governor from a list of three (3) names
17	submitted by the State Board of Education;
18	$\frac{(11)}{(10)}$ One (1) member who is actively engaged in distance
19	learning activities for kindergarten through grade twelve (K-12) education
20	appointed by the Governor from the state at large;
21	$\frac{(12)}{(11)}$ Two (2) members who are employed by telecommunications
22	companies that are members of the Arkansas Telecommunications Association and
23	appointed as follows:
24	(A) One (1) member shall be employed by a
25	telecommunications company with more than seventy-five thousand (75,000)
26	access lines and shall be appointed by the Governor from a list of three (3)
27	names submitted by the association; and
28	(B) One (1) member shall be employed by a
29	telecommunications company with less than seventy-five thousand (75,000)
30	access lines and shall be appointed by the Governor from a list of three (3)
31	names submitted by the association; and
32	$\frac{(13)}{(12)}$ Members added by the commissioner to the coordinating
33	council to represent other entities that are associated with kindergarten
34	through grade twelve (K-12) distance learning and that come into existence
35	after September 1, 2005.

           SECTION 2. DO NOT CODIFY. The enactment and adoption of this act

     session of the Ninetieth General Assembly. All such acts shall have the full
