15 TO MAKE TECHNICAL CORRECTIONS TO TITLE 26  
16 OF THE ARKANSAS CODE CONCERNING TAXATION.

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
20

21 SECTION 1. Arkansas Code § 26-57-610(b)(4), concerning the disposition  
22 of insurance premium taxes, is repealed as obsolete.

23 ~~(4) Amounts collected under §§ 26-57-604 and 26-57-605 above the~~  
24 ~~forecasted level for insurance premium taxes set by the Chief Fiscal Officer~~  
25 ~~of the State under § 10-3-1404(a)(1)(A) shall be credited by the Treasurer of~~  
26 ~~State to the Arkansas Medicaid Program Trust Fund and shall be disbursed and~~  
27 ~~used for the sole purpose of increasing per diem reimbursement for general~~

4 SECTION 2. DO NOT CODIFY. The enactment and adoption of this act  
5 shall not repeal, expressly or impliedly, the acts passed at the regular  
6 session of the Ninetieth General Assembly. All such acts shall have the full  
7 force and effect, and so far as those acts intentionally vary from or  
8 conflict with any provision contained in this act, those acts shall have the  
9 effect of subsequent acts and as amending or repealing the appropriate parts  
10 of the Arkansas Code of 1987.
