20	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:	
21		
22	SECTION 1. Arkansas Code § 25-10-128(d), concerning an advisory	
23	council to the Division of Community Service and Nonprofit Support, is	
24	repealed.	
25	(d) The program and staff of the Division of Community Service and	
26	Nonprofit Support will be assisted by an advisory council. It will be the	
27	responsibility of this council to assist the staff in setting goals,	
28	establishing priority activities, performing an advocacy role, and assisting	<del>.1g</del>
29	in funding and resource development and publicity and recognition and aware	<del>ls</del>
30	programs. Council members shall be appointed by the Governor from existing	
31	state, local, and private agencies that operate volunteer programs and sha	11
32	serve at the pleasure of the Governor.

34	SECTION 2. Arkansas Code Title 25, Chapter 10, Subchapter 1, is	
35	amended to add an additional section to read as follows:

2	(a) There is established a Governor's Advisory Commission on National							
3	Service and Volunteerism.							
4	(b) The purposes of the advisory commission are to:							
5	(1) Assist the program and staff of the Division of Community							
6	Service and Nonprofit Support of the Department of Human Services in setting							
7	goals, establishing priority activities, performing an advocacy role, and							
8	assisting in funding and resource development and publicity and recognition							
9	and awards programs; and							
10	(2) Serve as the state commission on national and community							
11	service for The Edward M. Kennedy Serve America Act, as governed by 42 U.S.C.							
12	<u>§ 12638.</u>							
13	(c)(l) The advisory commission shall consist of fifteen (15) to							
14	twenty-five (25) voting members to be appointed by the Governor.							
15	(2) The voting members shall include:							
16	(A) One (1) or more members with expertise in the							
17	educational, training, and developmental needs of youth, particularly							
18	disadvantaged youth;							
19	(B) One (1) or more members with experience in promoting							
20	the involvement of older adults in service and volunteering;							
21	(C) One (1) or more members representing community-based							
22	agencies or community-based organizations;							
23	(D) One (1) or more members representing local							
24	governments;							
25	(E) One (1) or more members representing local labor							
26	organizations;							
27	(F) One (1) or more members representing business;							
28	(G) One (1) or more members between sixteen (16) and							
29	twenty-five (25) years of age who is a participant or supervisor in a							
30	volunteer or service program;							
31	(H) One (1) or more members representing a national							
32	service program described in 42 U.S.C. § 12572, as it existed on January 1,							
33	<u>2015; and</u>							
34	(I) The Commissioner of Education or his or her designee.							
35	(3) The voting members may also include:							
36	(A) One (1) or more members selected from among local

2	(B) One (1) or more members selected from among experts in							
3	the delivery of human, educational, environmental, or public safety services							
4	to communities and persons;							
5	(C) One (1) or more representatives of Native American							
6	tribes;							
7	(D) One (1) or more members selected from among out-of-							
8	school youth or other at-risk youth; and							
9	(E) One (1) or more representatives of entities that							
10	receive assistance under the Domestic Volunteer Service Act of 1973, 42							
11	U.S.C. § 4950 et seq., as it existed on January 1, 2015.							
12	(4) The Corporation for National and Community Service may							
13	appoint an ex-officio nonvoting member of the advisory commission.							
14	(5) The number of voting members who are state employees or							
15	officers may not exceed twenty-five percent (25%) of the total membership.							
16	(6)(A) The Governor shall ensure, to the maximum extent							
17	practicable, that the membership of the advisory commission is diverse with							
18	respect to race, ethnicity, age, gender, and disability characteristics.							
19	(B) Not more than fifty percent (50%) of the voting							
20	members, plus one (1) additional member, may be from the same political							
21	party.							
22	(d)(1) A member of the advisory commission shall be appointed for							
23	terms of three (3) years.							
24	(2) The members initially appointed shall draw lots for							
25	staggered terms, such that an equal number of terms shall expire each							
26	<u>calendar year.</u>							
27	(3)(A) In the event of a vacancy, the Governor shall appoint an							
28	eligible member to serve the remainder of the term.							
29	(B) The vacancy shall not affect the power of the							
30	remaining members to execute the duties of the advisory commission.							
31	(e) The voting members of the advisory commission shall elect one (1)							
32	of the voting members to serve as chair.							
33	(f) A member of the advisory commission shall serve without							
34	compensation, but may receive expense reimbursements in accordance with § 25-							
35	<u>16-902.</u>							
36	(g) The Division of Community Service and Nonprofit Support may
