15	SECTION 6. LEGISLATIVE INTENT. It is the intent of th	e General

17	contained in this act shall be in compliance with the stated	reasons for		
18	which this act was adopted, as evidenced by the Agency Reque	sts, Executive		
19	Recommendations and Legislative Recommendations contained in	the budget		
20	manuals prepared by the Department of Finance and Administra	tion, letters, or		
21	summarized oral testimony in the official minutes of the Ark	ansas Legislative		
22	Council or Joint Budget Committee which relate to its passag	e and adoption.

24	SECTION 7. EMERGENCY CLAUSE. It is found and determin	ed by the General		
25	Assembly, that the Constitution of the State of Arkansas pro	hibits the		
26	appropriation of funds for more than a one (1) year period;	that the		
27	effectiveness of this Act on July 1, 2015 is essential to the	e operation of		
28	the agency for which the appropriations in this Act are prov	ided, and that in		
29	the event of an extension of the legislative session, the de	lay in the		
30	effective date of this Act beyond July 1, 2015 could work in	reparable harm		
31	upon the proper administration and provision of essential go	<u>vernmental</u>		
32	programs. Therefore, an emergency is hereby declared to exis	t and this Act		
33	being necessary for the immediate preservation of the public	peace, health		
34	and safety shall be in full force and effect from and after	July 1, 2015.
