12	(1) Is a member of the congregation of the church or other place

14	(2) Participates in any organized function or activity		
15	administered, supervised, or operated by the church or other place of		
16	worship; or		
17	(3) Participates in any activity on the grounds of the church or		
18	other place of worship that involves a minor.
