22	SECTION 1. APPR	OPRIATION - RAINY DAY FUNDS. There i	s hereby
23	appropriated, to the Office of the Governor, to be payable from the General		
24	Improvement Fund or i	ts successor fund or fund accounts, t	he following:
25	(A) for "Rainy	Day Set-Aside" in the 90th Session Pr	ojects Account of
26	the General Improveme	nt Fund for transfers, from time to t	ime, to the various
27	fund and fund account	s in the Revenue Stabilization Law as	amended, or for
28	transfers, from time	to time, for projects in the Executiv	e Discretionary
29	Division in the 90th	Session Projects Account of the Gener	al Improvement
30	Fund, in a sum not to	exceed	\$10,000,000.

32	SECTION 2. DISB	URSEMENT CONTROLS. (A) No contract m	ay be awarded nor
33	obligations otherwise	incurred in relation to the project	or projects
34	described herein in excess of the State Treasury funds actually available		
35	therefor as provided	by law. Provided, however, that inst	itutions and
36	agencies listed herei	n shall have the authority to accept	and use grants and

- 1 donations including Federal funds, and to use its unobligated cash income or
- 2 funds, or both available to it, for the purpose of supplementing the State
- 3 Treasury funds for financing the entire costs of the project or projects
- 4 enumerated herein. Provided further, that the appropriations and funds
- 5 otherwise provided by the General Assembly for Maintenance and General
- 6 Operations of the agency or institutions receiving appropriation herein shall
- 7 not be used for any of the purposes as appropriated in this act.
- 8 (B) The restrictions of any applicable provisions of the State Purchasing
- 9 Law, the General Accounting and Budgetary Procedures Law, the Revenue
- 10 Stabilization Law and any other applicable fiscal control laws of this State
- 11 and regulations promulgated by the Department of Finance and Administration,
- 12 as authorized by law, shall be strictly complied with in disbursement of any
- 13 funds provided by this act unless specifically provided otherwise by law.

Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative

Council or Joint Budget Committee which relate to its passage and adoption.

Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a one (1) year period; that the effectiveness of this Act on July 1, 2015 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an extension of the legislative session, the delay in the effective date of this Act beyond July 1, 2015 could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 2015.
