31	therefor as provided by law. Provided, however, that institutions and			
32	agencies listed herein shall have the authority to accept and use grants and			
33	donations including Federal funds, and to use its unobligated cash income or

SECTION 3. LEGISLATIVE INTENT. It is the intent of the General
Assembly that any funds disbursed under the authority of the appropriations
contained in this act shall be in compliance with the stated reasons for
which this act was adopted, as evidenced by the Agency Requests, Executive

summarized oral testimony in the official minutes of the Arkansas Legislative

20 <u>SECTION 4. EMERGENCY CLAUSE.</u> It is found and determined by the General

21 <u>Assembly, that the Constitution of the State of Arkansas prohibits the</u>

22 appropriation of funds for more than a one (1) year period; that the

23 effectiveness of this Act on July 1, 2015 is essential to the operation of

24 the agency for which the appropriations in this Act are provided, and that in

25 <u>the event of an extension of the legislative session, the delay in the</u>

26 <u>effective date of this Act beyond July 1, 2015 could work irreparable harm</u>

27 <u>upon the proper administration and provision of essential governmental</u>

28 programs. Therefore, an emergency is hereby declared to exist and this Act

being necessary for the immediate preservation of the public peace, health

30 and safety shall be in full force and effect from and after July 1, 2015.
