4	(i) An automobile insurer paying medical or hospital		
5	benefits under § 23-89-202(1); or		
6	(ii) A person, company, or organization that issues

8	contract in this state as described in §§ $23-62-102$ and $23-62-104-23-62-10$		
9	providing medical or hospital benefits for an accidental injury or		
10	disability;		
11	(3) "Prior authorization" means the process by which a health		
12	carrier determines the medical necessity or medical appropriateness, or both,		
13	of a covered healthcare service before a covered person receives the covered		
14	healthcare service in order to provide coverage and reimbursement for the		
15	healthcare service; and		
16	(4) "Terminal illness" means an illness, a progressive disease,		
17	or an advanced disease state from which:		
18	(A) There is no expectation of recovery; and		
19	(B) Death as a result of the illness or disease is		
20	reasonably expected within six (6) months.		
21	(b) A health carrier shall not require a covered person to obtain		
22	prior authorization for coverage and reimbursement of any medication		
23	prescribed as treatment for pain and suffering from a terminal illness if the		
24	covered person has been diagnosed with a terminal illness.
