SECTION 20. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CARRY FORWARD. Notwithstanding any law pertaining to the transfer of year-end fund balances or any law to the contrary, any funds which remain in the Department of Education Fund Account at the end of a fiscal year shall remain in the Department of Education Fund Account and made available to fund appropriation authorized by law and made payable from the Department of Education Fund Account for the following fiscal year.

Any carry forward of unexpended balance of funding as authorized herein, may be carried forward under the following conditions:

- (1) Prior to June 30, ~~2015~~ 2016 the Agency shall by written statement

1 set forth its reason(s) for the need to carry forward said funding to the
2 Department of Finance and Administration Office of Budget;

3 (2) The Department of Finance and Administration Office of Budget shall
4 report to the Arkansas Legislative Council all amounts carried forward by the
5 September Arkansas Legislative Council or Joint Budget Committee meeting
6 which report shall include the name of the Agency, Board, Commission or
7 Institution and the amount of the funding carried forward, the program name
8 or line item, the funding source of that appropriation and a copy of the
9 written request set forth in (1) above;

10 (3) Each Agency, Board, Commission or Institution shall provide a
11 written report to the Arkansas Legislative Council or Joint Budget Committee
12 containing all information set forth in item (2) above, along with a written
13 statement as to the current status of the project, contract, purpose etc. for
14 which the carry forward was originally requested no later than thirty (30)
15 days prior to the time the Agency, Board, Commission or Institution presents
16 its budget request to the Arkansas Legislative Council/Joint Budget
17 Committee; and

18 (4) Thereupon, the Department of Finance and Administration shall
19 include all information obtained in item (3) above in the budget manuals
20 and/or a statement of non-compliance by the Agency, Board, Commission or
21 Institution.

22 The provisions of this section shall be in effect only from July 1,
23 2015 through June 30, 2016.

24

25 SECTION 21. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
26 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. SALARY OF
27 THE COMMISSIONER OF THE DEPARTMENT OF EDUCATION. It is the intent of the
28 General Assembly that the appropriation for the salary of the Commissioner of
29 the Department of Education shall be the sole and exclusive authority for his
30 or her salary. It is further the intent of the General Assembly that the
31 Commissioner be required to devote all of his or her working time exclusively
32 to the performance of his or her duties as Commissioner of the Department of
33 Education. Therefore, the Commissioner of the Department of Education is
34 hereby prohibited from accepting any additional salary from any other source
35 (including state, federal, or private entities or persons) for the
36 performance of his or her duties as Commissioner, and is prohibited from

1 accepting any salary, fees or compensation from any other source (including
2 state, federal or private entities or persons) for any other employment of
3 any kind outside the scope of his or her duties as Commissioner, including
4 but not limited to consulting work for any other public or private entity.
5 This section shall not be construed to prohibit the Commissioner from
6 accepting or receiving expense reimbursements and employee benefits as
7 provided by State law.

8 The provisions of this section shall be in effect only from July 1,
9 2015 through June 30, 2016.

10
11 SECTION 22. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
12 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. ARKANSAS
13 LEADERSHIP ACADEMY - REDUCTION OF FUNDS RESTRICTION. Upon determination by
14 the Department of Education that a reduction in the amount of available
15 appropriation within the Department of Education Fund Account is required
16 from the amount appropriated, the reduction in the available appropriation
17 from the full amount appropriated for the Arkansas Leadership Academy shall
18 be limited to the average percentage reduction in the other appropriations to
19 the Department of Education from the Department of Education Fund Account.

20 The provisions of this section shall be in effect only from July 1, ~~2014~~
21 2015 through June 30, ~~2015~~ 2016.

22
23 SECTION 23. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
24 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
25 LEADERSHIP ACADEMY. The funds appropriated in the "AR LEADERSHIP ACADEMY"
26 line item in Section 3 of this Act shall be used for the School Support
27 Program which will provide support to schools or school districts designated
28 by the Department of Education as being in school improvement status and to
29 provide for general operations of the Leadership Academy.

30 The provisions of this section shall be in effect only from July 1, ~~2014~~
31 2015 through June 30, ~~2015~~ 2016.

32
33 SECTION 24. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
34 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. STATE
35 FUND RESTRICTIONS. No state funds shall be used for abortion referral in
36 public schools, or for abortion services. Funds shall be expended in

1 accordance with Arkansas Code Annotated § 6-18-703.

2 The provisions of this section shall be in effect only from July 1, ~~2014~~
3 2015 through June 30, ~~2015~~ 2016.

4
5 SECTION 25. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
6 authorized by this act shall be limited to the appropriation for such agency
7 and funds made available by law for the support of such appropriations; and
8 the restrictions of the State Procurement Law, the General Accounting and
9 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
10 Procedures and Restrictions Act, or their successors, and other fiscal
11 control laws of this State, where applicable, and regulations promulgated by
12 the Department of Finance and Administration, as authorized by law, shall be
13 strictly complied with in disbursement of said funds.

14
15 SECTION 26. LEGISLATIVE INTENT. It is the intent of the General
16 Assembly that any funds disbursed under the authority of the appropriations
17 contained in this act shall be in compliance with the stated reasons for
18 which this act was adopted, as evidenced by the Agency Requests, Executive
19 Recommendations and Legislative Recommendations contained in the budget
20 manuals prepared by the Department of Finance and Administration, letters, or
21 summarized oral testimony in the official minutes of the Arkansas Legislative
22 Council or Joint Budget Committee which relate to its passage and adoption.

23
24 SECTION 27. EMERGENCY CLAUSE. It is found and determined by the
25 General Assembly, that the Constitution of the State of Arkansas prohibits
26 the appropriation of funds for more than a one (1) year period; that the
27 effectiveness of this Act on July 1, 2015 is essential to the operation of
28 the agency for which the appropriations in this Act are provided, and that in
29 the event of an extension of the legislative session, the delay in the
30 effective date of this Act beyond July 1, 2015 could work irreparable harm
31 upon the proper administration and provision of essential governmental
32 programs. Therefore, an emergency is hereby declared to exist and this Act
33 being necessary for the immediate preservation of the public peace, health
34 and safety shall be in full force and effect from and after July 1, 2015.
